The City Engineer was instructed to check the bids submitted and report to the Council.

A proposed emergency ordinance entitled "AN EMERGENCY ORDINANCE CONCERNING THE SALE OF CERTAIN FOOD AND THE INSPECTION THEREOF WITHIN THE CITY OF GRAND JUNCTION" was presented and read. It was moved by Councilman Meders, seconded by Councilman Murr that the ordinance as read be passed and adopted, numbered 341 and published in the Daily Sentinel the official paper of the City of Grand Junction, upon this motion the following vote was cast: Councilmen voting Yea, Hirons, Marshall, Meders, Miller, Dowrey, Hampson and Murr. All the Councilmen present voting Yea, the President declared the motion carried.

J.J. Vandemoer was present asking what was to be done with the center parking on Gunnison Ave.

It was moved by Councilman Hampson, seconded by Councilman Dowrey that the City Manager and the City Attorney be instructed to investigate the matter of what material was to be used in the center parking by the street railway company and to endeavor to get the work started, and to report to the Council at the next regular meeting. Motion carried.

It was moved by Councilman Dowrey, seconded by Councilman Hampson that the President appoint a committee of three from the Council and City Manager Garrett and City Attorney Jordan to meet with the representatives of the Orman Construction Company to discuss the matter of the payment of moneys due the Burns and McDonnell Engineering Company for engineering services on the water works improvement. Said amount having been deducted from the contractor's estimates for work performed on said improvements. Said committee to recommend the action to be taken by the council. Motion carried, and the following councilmen were appointed to act on said committee, Marshall, Miller, & Murr.

It was moved by Councilman Murr, seconded by Councilman Miller that estimate as read be accepted and allowed, upon this motion the following vote was cast: Councilmen voting Yea, Hirons, Marshall, Meders, Dowrey, Hampson, Miller and Murr. All the Councilmen present voting yea the motion was declared carried.

The proof of publication of the ordinance entitled "AN ORDINANCE CONCERNING THE SALARY AND COMPENSATION OF THE CITY ATTORNEY" was read, upon motion of Councilman Murr, seconded by Councilman Hampson the proof was accepted and filed. #342

The ordinance was then brot up for final passage and read by the Clerk; It was moved by Councilman Dowrey, seconded by Councilman Murr that Section 1 of said ordinance be amended to read as follows:

Sec. 1. That the salary of the City attorney of the City of Grand Junction Colorado, shall be \$150.00 a month, payable at the end of each month, beginning with the 21st of November, A.D. 1923, and in addition thereto for preparing all proceedings and records for each local improvement district created under ordinance No. 178 as amended, the City Attorney shall receive as compensation therefor, the sum of \$50.00 for each district costing \$10,000.00 or more, said amount to be charged against said district, and this ordinance shall also apply to all incompleted local improvement districts costing \$10,000.00 or more, wherein the assessing ordinance has not as yet been passed, upon this motion the following vote was cast: Councilmen voting Yea: Hirons, Marshall., Meders, Miller, Dowrey, Hampson and Murr. All the Councilmen voting Yea, the president declared the motion carried.

It was then moved by Councilman Murr, Seconded by Councilman Hampson that the ordinance as read and amended be passed and adopted. Upon this motion the following vote was cast: Councilman voting Yea, Hirons, Marshall, Meders, Miller, Dowrey, Hampson and Murr. All the Councilmen present voting yea the President declared the motion carried.

The President adjourned the meeting for a short recess.

After a short recess the President of the Council again called the Council to order.

It was moved by Councilman Murr, seconded by Councilman Hampson that vitrified clay pipe be used in the construction of Combined Sewer District No. 2. Upon this motion the following vote was cast: Councilmen voting Yea; Hirons, Marshall, Meders, Miller, Hampson, Dowrey and Murr. All the Councilmen voting Yea, the president declared the motion carried.

It was moved by Councilman Dowrey, seconded by Councilman Miller that the construction of the South Trunk Line of Combined Sewer District # 2 be awarded to the firm Pendergast and Conner of Denver they being the lowest and best bidder their bid being the sum of \$33,638.88, said contract being subject to the sale and approval of the bonds for said district, upon which motion the following vote was cast: Councilmen voting Yea; Hirons, Marshall, Meders, Miller, Dowrey, Hampson and Murr. All the Councilmen voting yea, the president declared the motion carried.

The City Engineer reported that the bids on the construction of Paving District No. 11 had been checked and that the Strange-MaGuire Paving Company was the lowest bidder on Warrenite-Bitulithic Paving, they bidding the sum of \$32386.74.

It was moved by Councilman Murr, seconded by Councilman Miller that the Strange-MaGuire Paving Company be awarded the contract for the construction of Paving District No. 11, said contract to be subject to the sale and approval of the bonds. Upon this motion the following vote was cast: Councilmen voting Yea, Hirons, Marshall, Meders, Miller, Hampson and Murr. Councilman Dowrey was excused before the vote was taken. All the Councilmen present voting yea, the President declared the motion carried.

There being no further business to come before the meeting the Council adjourned upon motion of Councilman Hampson and seconded by Councilman Miller.
