January 7 1924

The City Council of the City of Grand Junction met in regular adjourned session at the hour of 7:30 P.M. with President Hirons presiding. Those present and answering at roll call were Councilmen Hirons, Meders, Miller, Hampson & Marshall, Murr, City Manager Garrett, City Clerk Peck. Councilmen Dowrey and City Attorney Jordan were absent.

The minutes of the last regular session and of the adjourned session of December 28th 1923 were read and approved.

A proposed ordinance entitled '"AN ORDINANCE AMENDING SECTIONS 1 & 4 OF ORDINANCE NO. 308 ENTITLED 'AN ORDINANCE PROVIDING FOR THE REGULATION AND LICENSING OF PUBLIC DANCE HALLS, BALL ROOMS, AND DANCING ACADEMIES AND PUBLIC DANCES, AND TO PROHIBIT AND RESTRAIN ALL IMMORAL OR INDECENT DANCES, AND DEFINING WHAT CONSTITUTES A PUBLIC DANCE HALL, BALL ROOM OR DANCING ACADEMY AND WHAT CONSTITUTES IMMORAL OR INDECENT DANCES, AND PROVIDING A PENALTY FOR THE VIOLATION OF THE PROVISIONS OF THIS ORDINANCE', PASSED AND ADOPTED THE 21ST DAY OF FEBRUARY, 1922"' was introduced and read. Upon motion of Councilman Murr, seconded by Councilman Marshall and unanimously carried the proposed ordinance was passed for publication.

A proposed ordinance entitled "AN ORDINANCE AMENDING SECTIONS 8 AND 12 OF ORDINANCE NO. 238 PASSED AND ADOPTED AUGUST, 10 1915" was introduced and read. It was moved by Councilman Meders, seconded by Councilman Murr that the ordinance as read be passed for publication. The motion was carried unanimously.

A proposed ordinance entitled "AN ORDINANCE CONCERNING SALARIES" was introduced and read. It was moved by Councilman Hampson, seconded by Councilman Murr that the ordinance as read be passed for publication, upon which motion the following vote was cast: Councilmen voting yea, Hirons, Meders, Miller, Hampson and Murr. Councilmen voting nay, Marshall. The majority of the Councilmen voting yea, the motion was declared carried.

It was moved by Councilman Murr, seconded by Councilman Miller that the City Clerk be authorized to deliver to Bosworth, Chanute & Company and the International Trust Company, both of Denver, Colo., \$40,000.00 bonds of Combined Sewer District #2. Motion carried.

A petition for the paving of certain alleys in blocks 116 & Block 127 was presented. Upon motion of Councilman Hampson, seconded by Councilman Murr, the same was accepted and filed. A communication from Attorney Sternberg of the Grand Valley National Bank in regard to money due them from the Conley Construction Company was read. This communication was referred to the City Attorney.

It was moved by Councilman Marshall, seconded by Councilman Meders that the Daily Sentinel be designated as the official newspaper for the City of Grand Junction for the year 1924. During the discussion of this matter the clerk read a letter from the Daily News asking to be designated as the official paper for the year 1924. The President stated the motion and the following Councilmen voted in favor of the same: Hirons, Marshall, Meders, Miller, and Hampson. Councilman Murr voted against the motion. The majority of the Councilmen voting for said motion the President declared the same carried.

It was moved by Councilman Marshall, seconded by Councilman Meders that the President of the Council be authorized to sign the contract with Pendergast and Conner for the construction of the South Trunk Line of Combined Sewer District No. 2, upon which motion the following vote was cast: Councilmen voting Yea, Hirons, Marshall, Miller, Meders, Hampson and Murr. All the Councilmen voting Yea, the President declared the motion carried.

It was moved by Councilman Miller, seconded by Councilman Meders that the estimate as read be accepted and allowed, upon which motion the following vote was cast: Councilmen voting Yea, Hirons, Marshall, Miller, Meders, Hampson and Murr. All the Councilmen present voting yea, the President declared the motion carried.

D.L. Cook made application for a permit to build a garage on Lot 17, Block 22, City of Grand Junction. It was moved by Councilman Meders, seconded by Councilman Miller that the permit be denied as this class of buildings were not wanted in the vicinity of Lincoln Park. Motion carried unanimously. City Manager Garrett stated that it would be advisable to extend the concrete sewer line being constructed in Comb. Sewer District #2 about 75' to the first manhole on South Fifth Street. The additional cost of this extention to be about \$26.00. It was moved by Councilman Meders seconded by Councilman Marshall that the concrete (Reinforced) sewer line in extended as outlined by City Manager Garrett, upon which motion the following vote was cast: Councilmen voting Yea, Hirons, Marshall, Meders, Miller, Hampson and Murr. All the Councilmen present voting yea, the President declared the motion carried.
