January 30 1924

The City Council of the City of Grand Junction met in regular session at 8:00 o'clock P.M. with President Hirons presiding. Those present and answering to roll call were Councilmen Hirons, Marshall, Meders, Miller, Dowrey Hampson and Murr, City Manager Garrett, City Clerk Peck, City Attorney Jordan and City Engineer Thompson.

The minutes of the last regular session were read and approved.

Jack Lumsden of the firm of Winterburn & Lumsden was present requesting that the balance due them for cast iron pipe and specials for the water improvement be paid. Mr. Warner of the M.J. O'Fallon Supply Company was present making the same request.

It was moved by Councilman Murr, seconded by Councilman Marshall that the amount due Winterburn & Lumsden for cast iron pipe and specials in the sum of \$8118.46 be paid less \$800.00 which is in dispute. Upon this motion the following vote was cast, Councilmen voting yea, Hirons, Marshall, Meders, Miller, Dowrey, Hampson and Murr. All the Councilmen voting yea, the President declared the motion carried.

It was moved by Councilman Hampson, seconded by Councilman Murr that the City Manager submit in writing, evidence as to the delay of the delivery of pipe for the improvements to the water system. Said evidence to be given to Winterburn & Lumsden and the M.J. O'Fallon Supply Company. Motion carried.

It was moved by Councilman Miller, seconded by Councilman Marshall that the City Council authorize the cancellation of tax sale certificates Nos. 24819, 24820, 24700 and 24701 which were erroneously sold by the County Treasurer, and that the owner of the property covered by said certificates be allowed to pay the taxes for the year 1923 as originally assessed., Upon which motion the following vote was cast: Councilmen voting Yea, Hirons, Marshall, Meders, Miller, Dowrey, Hampson and Murr. All the Councilmen voting Yea, the President declared the motion carried.

The proof of publication of the proposed ordinance entitled "AN ORDINANCE CONCERNING SALARIES" was presented and read. It was moved by Councilman Meders seconded by Councilman Miller that the proof of publication be accepted and filed. Motion carried.

It was moved by Councilman Meders, seconded by Councilman Murr that the proposed ordinance as read be passed and adopted, upon which motion the following vote was cast, Councilmen voting Yea, Hirons, Meders, Miller, Meders, Dowrey, Hampson and Murr. Councilmen voting Nay, Marshall. The majority of the Councilmen voting Yea, the President declared the motion carried.

The proof of publication of the proposed ordinance entitled" AN ORDINANCE AMENDING SECTIONS 8 & 12 OF ORDINANCE NO. 238, PASSED AND ADOPTED AUGUST, 10 1915" was presented and read. Upon motion of Councilman Murr, seconded by Councilman Miller the proof of publication was accepted and filed.

The proposed ordinance entitled "AN ORDINANCE AMENDING SECTIONS 8 & 12 OF ORDINANCE NO. 238, PASSED AND ADOPTED AUGUST, 10 1915" was presented and read. It was moved by Councilman Murr, seconded by Councilman Miller that Paragraph 4 of Section 1 be amended so as to read as follows: For stands on public streets and thoroughfares for the sale of magazines and papers, a license of \$36.00 per year, \$25.00 for six months, \$2.00 per day; for stands on public streets and thoroughfares for the sale of peanuts and popcorn, a license of \$50.00 per year, \$35.00 for six months, \$3.00 per day; for stands on public streets and thoroughfares for the sale of any other food stuff, soft drinks and novelties a license of \$100.00 per year, \$50.00 for six months, \$50.00 per day. This section shall not include hawkers. Upon which motion the following vote was cast. Councilmen voting Yea, Hirons, Marshall, Meders, Miller, Dowrey and Murr. Councilmen Hampson being excused by the President before the putting of said motion. All the Councilmen present voting yea, the President declared the motion carried. It was then moved by Councilman Murr, seconded by Councilman Meders that the ordinance be passed and adopted as read and amended, upon this motion the following vote was cast: Councilmen voting Yea, Hirons, Marshall, Meders, Miller, Dowrey and Murr. All the Councilmen present voting yea, the president declared the motion carried.

The proof of publication of the proposed ordinance entitled "AN ORDINANCE LICENSING, REGULATING PUBLIC HOTELS, ROOMING HOUSES, LODGING HOUSES, WITHIN THE CITY OF GRAND JUNCTION AND DEFINING WHAT ARE PUBLIC HOTELS, ROOMING HOUSES, LODGING HOUSES WITHIN THE MEANING OF THIS ORDINANCE" was read. Upon motion of Councilman Murr, seconded by Councilman Meders the proof of publication was accepted and filed.

The proposed ordinance entitled "AN ORDINANCE LICENSING, REGULATING PUBLIC HOTELS, ROOMING HOUSES, LODGING HOUSES, WITHIN THE CITY OF GRAND JUNCTION AND DEFINING WHAT ARE PUBLIC HOTELS, ROOMING HOUSES, LODGING HOUSES WITHIN THE MEANING OF ORDINANCE" WAS READ BY THE CLERK. It was moved by Councilman Murr, seconded by Councilman Meders that Section 4 of said ordinance be amended so that part pertaining to the license fee would read as follows: For hotels, rooming houses, or lodging houses having not less than two nor more than ten beds, \$2.50 per year. Upon this motion the following vote was cast. Councilmen voting yea, Hirons, Marshall, Meders, Miller, Dowrey and Murr. All the Councilmen present voting yea, the president declared the motion carried. It was then moved by Councilman Meders, seconded by Councilman Murr that the proposed ordinance as read and amended be passed and adopted, upon this motion the following vote was cast: Councilmen voting yea, Hirons, Marshall, Meders, Miller, Dowrey and Murr. All the Councilmen present voting yea, the president declared the motion carried.

A bill from the Denver and Rio Grande Western Ry. Co. was presented. Said bill being for one half the cost of the salary of the crossing watchmen employed on the West Main Street Crossing. The City Attorney advised the Council not to pay this bill as it was his opinion that the contract entered into between the City and the Railroad company in 1894 was not binding as the Council at that time had no right to contract away the police power of the city.

It was suggested by Councilman Murr that the awnings on Main Street be raised to comply with the ordinances. This matter was referred to the City Manager.

There being no further business to come before the meeting the Council adjourned upon motion of Councilman Murr, seconded by Councilman Marshall.
