

Grand Junction, Colo.

February 6 1924

The City Council of the City of Grand Junction, Colorado met in regular session at 8:00 o'clock P.M. with president Hirons presiding. Those present and answering at roll call were: Councilmen Hirons, Marshall, Hampson, Meders, Miller, and Murr. City Manager Garrett, City Clerk Peck, City Attorney Jordan. Councilman Dowrey was absent. City Engineer Thompson was absent.

Petitions requesting that certain names be stricken from the paving petitions for the paving of Grand Ave, White Ave, Ouray Ave, Gunnison Ave were presented and read. It was moved by Councilman Hampson, seconded by Councilman Miller that the petitions be accepted and filed and that the names appearing on said requests for withdrawal be stricken from the paving petitions. Upon which motion the following vote was cast, Councilmen voting yea, Hirons, Marshall, Miller, Meders, Hampson and Murr. All the Councilmen present voting Yea, the President declared the motion carried.

A petition for the paving of Grand Ave. from First Street to Twelfth St was presented and read.

It was moved by Councilman Murr, seconded by Councilman Miller that the petition be accepted and filed, subject however to the withdrawal of names requested. Motion carried.

A petition for the paving of Chipeta Ave from First St. to Seventh St. was presented and read.

It was moved by Councilman Murr, seconded by Councilman Meders that the petition be accepted and filed, subject however to the withdrawal of names requested on withdrawal petitions. Motion carried.

A petition for the paving of Gunnison Ave. from First St. to Seventh St was presented and read.

It was moved by Councilman Meders, seconded by Councilman Murr that the petition be accepted and filed, subject however to the requests for withdrawals heretofore filed. Motion carried.

Upon motion of Councilman Murr, seconded by Councilman Marshall that the proof of publication be accepted and filed.

The proposed ordinance entitled "AN ORDINANCE AMENDING SECTION 1 OF ARTICLE 3 OF ORDINANCE NO 92, PASSED AND ADOPTED FEBRUARY 19 1900, AND ENTITLED 'AN ORDINANCE CONCERNING WATERWORKS AND TO REPEAL CERTAIN OTHER ORDINANCES" was read by the Clerk. It was moved by Councilman Murr, seconded by Councilman Marshall that the Ordinance as proposed and read be passed and adopted, upon which motion the following vote was cast: Councilmen present voting yea, Hirons, Marshall, Miller, & Murr. Councilmen voting Nay: Meders. The majority of the Councilmen present voting Yea, the President declared the motion carried.
