Grand Junction, Colo.

March 5 1924

The City Council of the City of Grand Junction met in regular session at 8:00 o'clock P.M. with President Hirons presiding. Those present and answering at roll call were: Councilmen Hirons, Meders, Miller, Hampson and Murr. City Manager Garrett, City Clerk Peck and City Attorney Jordan. Councilmen Dowrey and Marshall were absent.

The minutes of the last regular session were read and approved.

It was moved by Councilman Meders, seconded by Councilman Miller that the cash payments on Comb. Sewer Dist. #1, Paving Dist. Nos. 7-8-9-10 and Sidewalk Districts Nos. 6 & 7 may be paid to the City Treasurer on or before thirty days after the final publication of the assessing ordinances which was published Feb. 22 1924. Upon this motion the following vote was cast: Councilmen voting yea, Hirons, Meders, Miller, Hampson and Murr. All the Councilmen present voting yea, the president declared the motion carried.

It was moved by Councilman Miller, seconded by Councilman Meders that the County Treasurer be authorized to mail out special notices to all property owners, showing improvement assessments, in C. Sewer Dist #1, Sdw Dist. Nos. 6 & 7, and Paving Districts Nos. 7-8-9-10. Upon which motion the following vote was cast: Councilmen voting Yea, Hirons, Meders, Miller, Hampson and Murr. All the Councilmen present voting Yea, the president declared the motion carried.

A resolution entitled "A RESOLUTION DECLARING THE INTENTION OF THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION TO CREATE A LOCAL PUBLIC IMPROVEMENT DISTRICT, SAID DISTRICT TO BE KNOWN AS PAVING DISTRICT NO. 12" was read by the Clerk.

D.W. Aupperle was present objecting to the passage of the resolution on the grounds that some of the signatures were illegally acknowledged and that some of the persons who signed the petition were not the actual owners of the property signed for. The following cases being cited: D. DeMershman signed petition but he does not own the property, Mrs. Ben Allison's name was signed by her son, Ben Allison, so claimed. Mr. Fred Rodgers name was signed by her son, Fred Rodgers, so claimed. It was also claimed by Aupperle that Mrs. Cherrington was not in the city when her name was signed to the petition. Mr. Aupperle not having affidavits to substantiate his statements it was moved by Councilman Murr, seconded by Councilman Miller that the resolution as read be passed and adopted. Upon which motion the following vote was cast: Councilmen voting yea, Hirons, Meders,

Miller, Hampson and Murr. All the Councilmen present voting yea, the president declared the motion carried.

A resolution entitled "A RESOLUTION DECLARING THE INTENTION OF THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO, TO CREATE A LOCAL PUBLIC IMPROVEMENT DISTRICT, SAID DISTRICT TO BE KNOWN AS COMBINED SEWER DISTRICT NO. 3" was read. Upon motion of Councilman Murr, seconded by Councilman Meders the resolution was unanimously adopted. After this motion was carried it was discovered that part of the description of the proposed sewer district was omitted and it was therefore moved by Councilman Murr, seconded by Councilman Miller that the action adopting the resolution be recinded. Upon which motion the following vote was cast: Councilmen present voting yea, Hirons, Meders, Miller, Hampson and Murr. All the Councilmen present voting yea, the president declared the motion carried.

Call for bids W. T. L. C. Sew. # 2.

It was moved by Councilman Murr, seconded by Councilman Meders that the City Clerk advertise for bids for the construction of the West Trunk Line of Combined Sewer District No. 2. Said bids to be received and opened on March 20 1924. Upon which motion the following vote was cast. Councilmen present voting yea, Hirons, Meders, Miller, Hampson and Murr. All the Councilmen present voting yea the motion was declared carried.

B.F. Clifton made a written request to cut the curb on the west side of Seventh Street between the South line of Main Street and the North line of the alley extending East and West in Block 118, in the City of Grand Junction, in order to construct a driveway from Seventh Street to a filling station situated on the corner of Seventh and Main Sts in Blk 118. He agreeing to keep said driveway in repair and to replace the curbing if the station is discontinued. He also made application to install two gasolene pumps and two storage tanks on said property.

It was moved by Councilman Murr, seconded by Councilman Meders that the request of B.F. Clifton be granted. Upon which motion the following vote was cast: Councilmen voting yea, Hirons, Meders, Miller, Hampson and Murr. All the Councilmen present voting yea, the president declared the motion carried.

It was moved by Councilman Murr, seconded by Councilman Miller that the Estimate #3 estimate as read be allowed. Upon which motion the following C. Sew. #2 vote was cast: Councilmen voting yea, Hirons, Meders, Miller, Hampson and Murr. All the Councilmen present voting yea, the President declared the motion carried.

It was moved by Councilman Hampson, seconded by Councilman Meders that the Estimate for estimate as read be allowed. Upon which motion the following vote was cast: Councilmen voting yea, Hirons, Meders, Miller Hampson and Murr. All the Councilmen present voting yea, the president declared the motion carried.

The bond of Bert Woodard was presented. Said bond being for a license to engage in the auctioneer business in the City. It was moved by Councilman Murr, seconded by Councilman Hampson that the bond be rejected as the surety was not sufficient and a surety bond given in it's place. Motion carried.

It was moved by Councilman Murr, seconded by Councilman Miller that the City Treasurer be authorized and instructed to cancell the water main frontage assessments on the Grover Packing Co. property in Benton Canon's subdivision as the same was not included in the city limits.

Upon this motion the following vote was cast: Councilmen voting Yea, Hirons, Meders, Miller, Hampson and Murr. All the Councilmen present voting yea, the President declared the motion carried.

An estimate of a proposed extention to Combined Sewer District No. 2 (south trunk line was presented and read. No action was taken on this matter.

A contract with the D. & R.G. Ry. Co in regard to placing a sewer line under the tracks on South Fifth Street was presented. The contract was referred to the City Attorney to chek over.

It was moved by Councilman Meders, seconded by Councilman Hampson that the applicants as before stated be given a license to conduct a rooming house or hotel on condition that the same were approved by the Chief of Police and that the license fee be paid. Motion carried.

It was moved by Councilman Murr, seconded by Councilman Meders that the City Clerk be instructed and authorized to call for sealed bids on \$29,500 of bonds of Paving District No. 11. Said bids to be received up to 8:00 o'clock P.M. March 20 1924. Upon which motion the following vote was cast: Councilmen voting yea, Hirons, Meders, Miller, Hampson and Murr. All the Councilmen present voting yea, the President declared the motion carried and the Clerk so instructed.

G.C. Reed made application for a permit to install a gasolene pump and tank at 639 Main Street. Upon motion of Councilman Hampson, seconded by Councilman Murr the application was referred to City Manager Garrett for investigation.

The matter of purchasing a Fire Truck for the City Fire Dept was brot up by City Manager Garrett and Fire Chief Hynes.

It was moved by Councilman Hampson, seconded by Councilman Meders that the President of the Council be authorized to sign a contract with the Julius Pearse Fire Dept. Supply Company for the purchase of one Type 89 American La France Fire Truck, the purchase price being \$9000.00 and that said Company give the city an allowance of \$2000.00 for the old SeaGrave Fire Truck. The terms of payment to be \$4000.00 cash on arrival and acceptance of the truck and the balance of \$3000.00 to be paid March 1st 1925.

Upon which motion the following vote was cast: Councilmen present voting yea, Hirons, Meders, Miller, Hampson and Murr. All of the Councilmen present voting yea, the president declared the motion carried.

It was moved by Councilman Murr, seconded by Councilman Hampson that the meeting adjourn until March 20 1924 at the hour of 7:30 p.m.
