

Grand Junction, Colo.

March 11 1924

All the Councilmen being duly notified the City Council of the City of Grand Junction met in special session at the hour of 7:30 o'clock P.M. with President Hirons presiding. Those present and answering to roll call were Councilmen Hirons, Marshall, Meders, Miller, and Dowrey. Councilmen absent were Hampson and Murr. City Manager Garrett, City Clerk Peck and City Attorney Jordan were present.

The President of the Council explained that the purpose of the meeting was to investigate certain paving petitions here-to-fore filed with the Council.

After some discussion as to the validity of the Paving petitions for Gunnison Ave, Grand Ave, Chipeta Ave and North Seventh Street it was moved by Councilman Dowrey, seconded by Councilman Marshall that the City Attorney draw up a resolution rescinding the resolution passed March 5th 1924 entitled "A RESOLUTION DECLARING THE INTENTION OF THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, TO CREATE A LOCAL PUBLIC IMPROVEMENT DISTRICT, SAID DISTRICT TO BE KNOWN AS PAVING DISTRICT NO. 12". Motion carried.

The following resolution was then introduced and read:

WHEREAS, on the 5th day of March, 1924, the City Council of the City of Grand Junction passed a Resolution entitled: " A Resolution declaring the intention of the City Council of the City of Grand Junction to create a local public improvement district, said District to be known as Paving District No. 12" and in and by said resolution, authorized, instructed, ordered and directed the City Engineer to prepare full details and specifications as well as an estimate of the total cost of said improvement, and furnish a map of the District, from which map the approximate share of the total cost that will be assessed upon each piece of real estate in the District may be readily ascertained; and

WHEREAS, since adopting said Resolution certain facts and evidence have been presented to the Council which raises a doubt or question as to whether or not, some of the petitions for Paving included within said proposed Paving District No. 12 were legally and properly subscribed and acknowledged by the owners of the necessary one-third of the frontage of the real estate to be assessed; and

WHEREAS, the Council deems best before proceeding further in the matter that a further check of each of said petitions be made.

THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

That the resolution heretofore passed by the City Council on the 5th day of March, 1924, entitled: "A Resolution declaring the intention of the City Council of the City of Grand Junction to create a local public public improvement district, said district to be known as Paving District No. 12", be and the same is hereby annulled, set aside and repealed, and that all orders and directions to the City Engineer as in said Resolution provided, be and the same are hereby cancelled, and that any other orders or proceedings under and by virtue of said Resolution be and the same are hereby cancelled.

It was moved by Councilman Dowrey, seconded by Councilman Miller that the resolution as read be passed and adopted. Upon which motion the following vote was cast: Councilmen voting yea, Hirons, Marshall, Meders, Miller and Dowrey. All the Councilmen present voting yea, the president declared the motion carried.

It was moved by Councilman Dowrey, seconded by Councilman Marshall that Lots 11 and 12 Block 55 be stricken from the petition as the same were added after the petition was filed. Motion carried.

It was moved by Councilman Dowrey, seconded by Councilman Marshall that the Council meet the property owners owning property of North Seventh St (between Teller Ave & North Ave) Grand Ave, Chipeta Ave at a meeting to be held on March 18 1924. Any affidavits said property owners wished to present would be filed and considered at that time. Motion carried.

There being no further business to come before the meeting, the Council adjourned.
