

Grand Junction, Colo.

October 30 1924

All of the Councilmen being duly notified, the City Council of the City of Grand Junction met in adjourned session at 8:00 o'clock A.M at the City Hall. Those present and answering at roll call were Councilmen Murr, Bear, Dowrey and Meders. Councilmen Hirons, Miller and Hampson were absent. City Manager Garrett, City Clerk Peck were present. City Attorney Jordan was absent.

Upon motion of Councilman Meders, seconded by Councilman Bear that Councilman Murr act as President Pro tem in the absence of President Hirons. Motion carried.

The following estimate was presented and read.

It was moved by Councilman Meders, seconded by Councilman Bear that the estimate as read be allowed and that the City Clerk be directed to cause the legal notice to all claimants to be printed notifying said claimants to file any claim against said W.O. Allison for work performed or materials furnished if the said claims had not been paid, and that final settlement with said W.O. Allison would be made on November 12 1924. Upon this motion the following vote was cast: Councilmen present voting yea, Murr, Bear, Meders and Dowrey. All the Councilmen present voting yea, the President declared the motion carried.

The City Clerk informed the Council that no bills had been filed against the Strange-MaGuire Paving Company for the construction of Paving District No. 11.

Councilman Meders moved, seconded by Councilman Bear that the City Auditor and the City Manager be authorized to draw warrants to the Strange-MaGuire Paving Company to cover the final estimate for the construction of Paving Dist. No. 11. as allowed by the Council Oct. 16 1924. Motion carried unanimously.

Councilman Meders moved, seconded by Councilman Bear that the City Council instruct the City Treasurer to cancel bonds Nos. 53 to 59 both inclusive, Paving District No. 11 as they are in excess of the amount required for the cost of the improvement. Motion carried unanimously.

Mr. J.W. Watson's request for lower water rates was taken up.

It was moved by Councilman Bear, seconded by Councilman Dowrey that the request of Mr. Watson for lower rates on water be denied. Motion carried unanimously.

It was moved by Councilman Dowrey, seconded by Councilman Bear that the City Manager and City Attorney be instructed to draft a new peoples ordinance providing for a lower charge for water used outside the city limits and that said ordinance be put on the ballot at the next election. Motion carried unanimously.

There being no further business to come before the meeting the Council adjourned.
