Grand Junction, Colorado

December 3 1924

The City Council of the City of Grand Junction met in regular session at 8:00 o'clock P.M. with President Hirons presiding. Those present and answering at roll call were Councilmen: Hirons, Meders, Miller, Dowrey, Hampson and Murr. City Manager Garrett, City Clerk Peck and City Attorney Jordan were present.

The minutes of the last regular session and of the adjourned session of November 28th were read and approved.

The proof of publication of the proposed ordinance entitled "AN ORDINANCE CONCERNING CANNABIS SATIVA (ALSO KNOWN AS CANNABIS INDICIA, INDIAN HEMP AND MARIGUANA) was introduced and read. Upon motion of Councilman Miller, seconded by Councilman Dowrey the proof was accepted and filed.

The proposed ordinance was then read by the Clerk.

Councilman Meders moved, seconded by Councilman Miller that the proposed ordinance entitled "AN ORDINANCE CONCERNING CANNABIS SATIVIA (ALSO KNOWN AS CANNABIS INDICIA, INDIAN HEMP AND MARIGUANIA" be passed and adopted as read and numbered 368. Upon which motion the following vote was cast: Councilmen voting yea, Bear, Dowrey, Hampson, Meders, Miller, Murr and Hirons. All the Councilmen present voting yea, the President declared the motion carried.

The bond of Carl Frederick Miller as electrician was presented the same having the approval of the City Attorney. Upon motion of Councilman Meders, seconded by Councilman Dowrey and unanimously carried the bond was approved and ordered filed.

A number of dairymen were present, they being interested in the passage of a revised Milk Ordinance.

A proposed ordinance entitled "AN ORDINANCE AMENDING ORDINANCE NO. 318 PASSED AND ADOPTED THE 24TH DAY OF MAY, 1922, ENTITLED 'AN ORDINANCE CONCERNING THE SALE, HANDLING AND DELIVERY OF MILK, AND INSPECTION AND REGULATING OF DAIRIES, REPEALING ORDINANCE NO. 177 PASSED AND ADOPTED MARCH 15TH, 1910, AND ADOPTED MARCH 15TH, 1910, AND EACH AND EVERY OTHER ORDINANCE AND PARTS THEREOF IN CONFLICT HEREWITH, BY ADDING THERETO A NEW SECTION NUMBERED 27A AND AMEND-SECTIONS 3, 6, AND 26 TP SAID ORDINANCE" was introduced and read.

Moved by Councilman Murr, seconded by Councilman Meders that the proposed ordinance as read be passed for publication. Motion carried.

A proposed emergency ordinance entitled "AN ORDINANCE LEVYING A SPECIAL ASSESSMENT ON CERTAIN REAL ESTATE IN GRAND JUNCTION, FOR BENEFITS CONFERRED BY THE WATER WORKS OF THE SAID CITY" was introduced and read.

Councilman Miller moved, seconded by Councilman Hampson that the proposed emergency ordinance entitled "AN ORDINANCE LEVYING A SPECIAL ASSESSMENT ON CERTAIN REAL ESTATE IN GRAND JUNCTION, FOR BENEFITS CONFERRED BY THE WATER WORKS OF THE SAID CITY" be passed and adopted as an emergency ordinance, numbered 369 and published. Upon which motion the following vote was cast: Councilmen voting Yea: Bear, Dowrey, Hampson, Meders, Miller, Murr and Hirons. All the Councilmen voting Yea, the motion was carried and the President declared the ordinance passed and adopted.

Dr. Drew, City Meat Inspector gave a partial report of his activities during the past year.

S.N. Wheeler presented a bill for \$2000.00, the same being for legal services as associate council for the City Attorney in the Case of Etta Gardner vs. The City of Grand Junction. Councilman Murr moved, seconded by Councilman Hampson that the bill be rejected. Motion carried unanimously.

Moved by Councilman Dowrey, seconded by Councilman Hampson that the meeting adjourn. Motion carried.
