Councilmen Murr & Dowrey were absent. Councilman Miller came in late.

The minutes of the last regular session and of the adjourned session of February 26th 1925 were read and approved.

The following resolution was introduced and read:

"Whereas under the terms and provisions of Ordinance No. 350 of the City of Grand Junction, passed and adopted on Feb. 20 1924, the matter of fixing the prices for the installation of lead water pipe was to be determined by resolution of the City Council, with power to change such prices from time to time as conditions should require; and

"Whereas because of the increased price of lead pipe, it is necessary that a change be made in the prices for such installation.

"Therefore Be It Resolved, that the following scale of prices shall be charged for lead water pipe connections made by the City of Grand Junction:

The above prices include Mueller or equivalent inverted key curb cock and stop box, also new tap where necessary.

The repairing, laying, or construction of service pipes for the distribution of water, connected with the main in the street

and extended to the stop box inside the curb line of the street in front of property to be served, shall be performed only by the Water Department of the City of Grand Junction, and it shall be unlawful for any person, firm or corporation to repair, lay, or construct such service pipe.

Service pipes of suitable size will be furnished upon application to the City Treasurer, at the City Hall, and the prepayment of the charges as above written.

"Be it further resolved that a notice including the foregoing resolution shall at once be posted by the City Clerk on the Bulletin Board in the City Hall, and that a notice shall be published in the Daily Sentinel by the City Clerk in two consecutive insertions therein, which notice shall contain a copy of this resolution.

Be it further resolved, that the foregoing scale of prices shall become effective five days after the first publication of said notice in said paper."

Councilman Meders moved, seconded by Councilman Hampson that the resolution as read be passed and adopted, upon which motion the following vote was cast: Councilmen voting YEA, Hirons, Meders, Miller, Hampson & Bear. Councilmen voting NAY, None. All the Councilmen present voting yea, the president declared the motion carried, and the resolution duly passed and adopted.

A communication from R.E. Tope, Sup. of Schools, regarding the proposed Junior College was read.

The following resolution was thereupon presented and read.

RESOLUTION

WHEREAS there is a bill now pending before the Legislature of the State of Colorado, providing for the establishment of a Junion College in Grand Junction, Colorado; and

WHEREAS in the opinion of the City Council of Grand Junction, Colorado, a Junior College established in said City would be of great benefit to the Western Slope; and

Whereas it is the desire of the said City and City Council thereof to encourage the passage of said bill and the establishment of the said Junior College in the City of Grand Junction; and

WHEREAS the City of Grand Junction is the owner of the West Half of Block Ninety-five (95) in said City, on which stands the Lowell School House, said school house belonging to School District No. 1 in said City, which school House is about to be replaced by said School District;

THEREFORE BE IT RESOLVED that the City Council does hereby

favor the passage of said bill and the establishment of said Junior College, and does hereby offer to the authorities in charge of such Junion College, should it be established, the free use of the ground on which the Lowell Building now stands, and does here-by offer to cooperate with School District No. 1 with the view of permitting the use of said Lowell School House until such time as permanent arrangements can be made for the proper housing of the said Junion College.

BE IT FURTHER RESOLVED that the City Council does hereby agree to lend its assistance and co-operation with the Chamber of Commerce and other organizations of said city, with the view of securing for said Junion College, should it be established in Grand Junction, a suitable site for necessary Junior College buildings.

AND BE IT FURTHER RESOLVED that the President of the City Council be and is hereby authorized and instructed to send a copy of these resolutions to the Honorable Ollie Bannister, Senator for Mesa County, the Honorable C.J. McCormack, member of the House of Representatives for Mesa County, and to the Honorable Sterling B Lacy, Lieutenant Governer of the State of Colorado.

Councilman Hampson moved, seconded by Councilman Meders that the resolution as read be passed and adopted, upon which motion the following vote was cast: Councilmen voting YEA, Hirons, Meders, Miller, Hampson & Bear. Councilmen voting NAY, None. All the Councilmen present voting YEA, the president declared the motion carried and the resolution duly passed and adopted.

Scott Heckman appeared before the Council asking that tax sale certificates on the property described as: Beg. 324 1/2 ft. North & 247 ft W. of the center line of S.E. 1/4, Sec. 15, 1S, 1W, thence east 50 ft., thence N.W.ly along R.O.W. to a point due N. of Beg., thence S. to beg. and Beg. 324 1/2 ft. N. & 247 ft. W. of center of Ssc. 15, 1S, 1W, thence W 87 1/2 ft., thence N. to Ry R.O.W., thence S. Ely along said R.O.W. to a point true N. of beg, thence S. to beg., and held by the City, be sold for the face of the certificate.

Councilman Hampson moved, seconded by Councilman Meders that the City Manager investigate the property above described and that he be authorized to dispose of the tax sale certificates on the same. Motion carried.

There being no further business to come before the meeting the Council adjourned upon motion of Councilman Hampson, seconded by Councilman Meders.
