

Grand Junction, Colo.

June 23 1925

The City Council of the City of Grand Junction met in regular adjourned session at 7:30 o'clock P.M. with President Bell presiding. Those present and answering at roll call were Councilmen: Bear, Ellison, Logsden, Meders, Moslander, Short & Bell; City Manager Thompson, City Attorney Hinman & City Clerk Peck.

Herbert Daves, Commander of the American Legion appeared before the Council stating that the American Legion had made arrangements with the Robinson Brothers Shows to show in this City on June 26th & 27th, the American Legion to get a percentage of the receipts of the show which would be placed to the credit of the American Legion Building Fund. Mr. Eaves requested that the Council waive the license fee of \$25.00 per day required by the City.

Thereupon Councilman Logsden moved, seconded by Councilman Meders that the license fee of \$25.00 per day be waived at the request of the American Legion. Motion carried.

A petition was presented by W.L. Downing for permission to erect a Service and filling station on Lots 18, 19 & 20, Block 44 (12th St. & Gunnison Ave.).

Councilman Meders moved, seconded by Councilman Moslander that the petition be filed and that the Clerk give the necessary notice as required by Ordinance. Motion carried.

The bond of A.H. Hale and H.L. Senter doing business as auctioneers was presented, the same having the approval of the City Attorney.

Councilman Meders moved, seconded by Councilman Moslander that the bond of A.H. Hale and H.L. Senter be accepted and filed. Motion carried.

Mr. Henry Tupper appeared before the Council in the interest of the Latimer Goodwin Chemical Co. as to the granting of a permit to said Company to occupy a portion of South Seventh Street below the D.& R.G. tracks. Mr. Tupper submitted a resolution granting to the Laitmer-Goodwin Chemical Co. a revocable permit to use said portion of Seventh Street. This resolution was read by the Clerk. Thereupon Councilman Ellison moved, seconded by Councilman Short that the resolution as read be passed and adopted, upon which motion the following vote was cast: Councilmen voting YEA, Ellison, Short & Bell. Councilmen voting NAY: Bear, Logsdan, Meders & Moslander. The majority of the Councilmen voting NAY, the President declared the motion lost.

The City Manager requested that the President of the Council appoint from the members of the Council Committees on Public Affairs; Streets, Alleys & Sewers, Fire & Police and Water.

Councilman Logsdan moved, seconded by Councilman Meders that the President of the Council appoint committees from the Council as suggested by the City Manager. Motion carried.

The President of the Council announced that he would appoint said Committees later.

A paving program was discussed at length the Council favoring the gravel type of pavement with curb and gutter. The City Manager gave estimates on the costs of the different types.

Councilman Moslander moved, seconded by Councilman Short that the City Council call a special election within the next 60 days from June 23rd 1925 to submit to the qualified electors of the City of Grand Junction the proposition of the issuance of \$86,000 bonds for the purpose of paying the cost of paving or gravelling street and alley intersection, the Council favoring at this time the gravel type of pavement with curb and gutter. The question being put all the Councilmen present voted Yea, excepting Councilman Ellison, who voted NAY. The majority of the

Councilmen voting YEA, the President declared the motion carried.

Councilman Short moved, seconded by Councilman Meders that the City Clerk be authorized to advertise for bids on \$86,000 of bonds for the purpose of paying the cost of paving street and alley intersections, said bids to be subject however to the results of the special election to be held within the next 60 days, the successful bidder to furnish all legal proceedings leading up to and after the election and to also furnish the printed bonds in such form as ordered by the City Council, that the bids be received on August 5th 1925, The bonds to be issued only as petitions are filed with the City Council for paving or gravelling. Motion carried.

A proposed ordinance entitled: "AN ORDINANCE AMENDING SECTION 12, OF ORDINANCE NO. 178, ENTITLED AN ORDINANCE PROVIDING FOR THE CREATION OF LOCAL IMPROVEMENT DISTRICTS, THE CONSTRUCTION THEREIN OF CERTAIN LOCAL IMPROVEMENTS, AND PROVIDING A METHOD OF PAYMENT THEREFOR' PASSED AND ADOPTED THE 11TH DAY OF JUNE, 1910" was introduced and read.

Councilman Meders moved, seconded by Councilman Bear that the proposed ordinance as read be passed

An ordinance entitled "AN ORDINANCE AMENDING SECTIONS 2, 4, 5 & 6 OF ORDINANCE NO. 236, PASSED AND ADOPTED MAY 18, 1915 AND ENTITLED 'AN ORDINANCE CONCERNING THE CUTTING OF WEEDS AND BRUSH AND THE REMOVAL OF WEEDS, BRUSH AND RUBBISH" was introduced and read as an emergency ordinance.

Councilman Short moved, seconded by Councilman Moslander that the proposed emergency ordinance entitled AN ORDINANCE AMENDING SECTIONS 2, 4, 5 & 6 OF ORDINANCE NO. 236, PASSED AND ADOPTED MAY 18 1915 AND ENTITLED' AN ORDINANCE

CONCERNING THE CUTTING OF WEEDS AND BRUSH AND THE REMOVAL OF WEEDS, BRUSH AND RUBBISH" be passed and adopted as an emergency ordinance, numbered 386 and published. Upon which motion the following vote was cast. Councilmen voting YEA, Bear, Ellison, Logsdan, Meders, Moslander, Short & Bell. All the Councilmen voting Yea, the President declared the motion carried and the emergency ordinance duly passed and adopted.

Upon motion of Councilman Moslander, seconded by Councilman Bear the Council adjourned.
