

Grand Junction, Colo.

December 21st 1925

The City Council of the City of Grand Junction met in regular adjourned session at 7:30 o'clock P.M. with President Bell presiding. Those present and answering at roll call were Councilmen Bear, Ellison, Fairley, Logsden, Moslander & Bell. Councilman Meders was absent. City Manager Thompson was absent. City Attorney Hinman, City Clerk Peck were present.

A proposed Ordinance entitled "AN ORDINANCE APPROVING THE WHOLE COST OF THE IMPROVEMENT MADE IN AND FOR SIDEWALK DISTRICT NO. 9 IN THE CITY OF GRAND JUNCTION COLORADO, PURSUANT TO ORDINANCE NO. 178, ADOPTED AND APPROVED JUNE 11 1910, AS AMENDED, AND PURSUANT TO THE RESOLUTIONS AND PROCEEDINGS OF THE CITY COUNCIL, ADOPTED PURSUANT TO SAID ORDINANCE NO. 178, AS AMENDED APPROVING THE APPORTIONMENT OF SAID COST TO EACH LOT OR TRACT OF LAND IN SAID DISTRICT, ASSESSING THE SHARE OF SAID COST AGAINST EACH LOT OR TRACT OF LAND IN SAID DISTRICT, AND PRESCRIBING THE MANNER FOR THE COLLECTION AND PAYMENT OF SAID ASSESSMENTS" was introduced and read. Upon motion of Councilman Bear, seconded by Councilman Logsden the proposed ordinance was passed for publication.

A proposed ordinance entitled "AN ORDINANCE APPROVING THE WHOLE COST OF THE IMPROVEMENT MADE IN AND FOR SEWER DISTRICT NO. 7 IN THE CITY OF GRAND JUNCTION, COLORADO, PURSUANT TO ORDINANCE NO. 178, ADOPTED AND APPROVED JUNE 11 1910, AS AMENDED, AND PURSUANT TO THE RESOLUTIONS AND PROCEEDINGS OF THE CITY COUNCIL, ADOPTED PURSUANT TO SAID ORDINANCE NO. 178, AS AMENDED APPROVING THE APPORTIONMENT OF SAID

COST TO EACH LOT OR TRACT OF LAND IN SAID DISTRICT, ASSESSING THE SHARE OF SAID COST AGAINST EACH LOT OR TRACT OF LAND IN SAID DISTRICT, AND PRESCRIBING THE MANNER FOR THE COLLECTION AND PAYMENT OF SAID ASSESSMENTS" was introduced and read. Upon motion of Councilman Bear, seconded by Councilman Logsdon the proposed ordinance was passed for publication

Councilman Moslander Moved, seconded by Councilman Logsdon that the meeting adjourn until 7:30 o'clock December 28th 1925 at which time the final passage of the License Ordinance and the Ordinance concerning Junk Dealers would be taken up. Motion carried.
