

Grand Junction, Colorado.

December 28th 1925.

The City Council of the city of grand junction met in regular adjourned session at 7:30 o'clock P.M. with president Bell presiding. This present and answering at roll call were Councilmen Bear, Ellison, Fairley, Logsden, Meders, Moslander, & Bell. City Attorney Hinman & City Clerk Peck were present. City Manager Thompson was absent.

The proof of publication of the proposed Ordinance entitled; "AN ORDINANCE AMENDING SECTIONS 2, 4, 5, 8, 7 12 OF ORDINANCE NO. 238 PASSED AND ADOPTED AUGUST 10TH 1915, AS AMENDED BY ORDINANCE 347 PASSED AND ADOPTED JANUARY 30TH 1924" was presented and read. Upon motion of Councilman Meders, seconded by Councilman Bear the proof of publication was accepted and filed.

The proposed ordinance was then read by the Clerk.

Councilman Meders moved, seconded by Councilman Logsden that paragraph 2 of Section 8 of the proposed ordinance be amended to read as follows: Street Peddlers carrying pack articles \$100.00 per annum or portion thereof. Peddlers with one or two horse wagon, automobile or and other kind of vehicle for the purpose of peddling or selling any article of merchandise other that foodstuffs and soft drinks, \$200.00 per annum. Peddlers with one or two horse wagon or automobile or any other kind of vehicle for the purpose of peddling or selling food stuffs and soft drinks, \$50.00 per annum or any portion thereof. Upon which motion the following vote was cast: Councilmen voting "YEA" Bear, Ellison, Fairley, Logsden, Meders, Moslander & Bell. All the Councilmen voting YEA the President declared the motion carried.

Upon motion of Councilman Logsden, seconded by Councilman Bear the proposed ordinance was brot up for final passage as amended.

Councilman Moslander moved, seconded by Councilman Bear that the proposed ordinance as read and amended by passed and adopted, upon which motion the following vote was cast: Councilmen voting YEA, Bear, Ellison, Fairley, Logsdan, Meders, Moslander, & Bell. All the Councilmen voting YEA, the President declared the motion carried and the ordinance duly passed and adopted. The ordinance was numbered 397.

The proof of publication of the proposed ordinance entitled "AN ORDINANCE CONCERNING JUNK YARDS AND JUNK DEALERS" was read. Upon motion of Councilman Meders, seconded by Councilman Bear the proof was accepted and filed.

The proposed ordinance was then read by the Clerk.

Councilman Meders moved, seconded by Councilman Bear that Section 1 of the proposed ordinance be amended so as to read as follows:

Section 1. Any person, persons, firm or corporation who shall buy, sell, barter, handle, trade or deal in old iron, steel, brass, copper, lead or other metals or papers, bottles, bones, rags, hides, or other like material or who shall engage in the business of wrecking or junking vehicles or machinery shall be termed junk dealers and subject to the provisions of this ordinance.

Upon motion of Councilman Bear, seconded by Councilman Moslander the ordinance was ordered brot up for final passage as amended.

Councilman Bear thereupon moved, seconded by Councilman Moslander that the proposed ordinance be passed and adopted as amended, upon which motion the following vote was cast: Councilmen voting YEA, Bear, Ellison, Fairley, Logsdan, Meders, Moslander & Bell. All the Councilmen voting Yea, the President declared the motion carried and the ordinance duly passed and adopted as amended. The ordinance was then numbered 398.

There being no further business to come before the meeting the Council

adjourned upon motion of Councilman Meders, seconded by Councilman Ellison.
