

Grand Junction, Colo.

May 19 1926.

The City Council of the City of Grand Junction, Colo., met in regular session at 7:30 o'clock P.M. with President Bell presiding. Those present and answering at roll call were Councilmen Bear, Ellison, Fairley, Logsdan, Meders, Moslander & Bell; City Manager Thompson, City Attorney Hinman & Leona Diehl Ex Officio City Clerk.

The minutes of the last regular session were read and approved.

H.J. Baker of the Continental Oil Company presented a request to replace the present White Eagle Oil Co. gas pump and tank at the Sam Pantuso grocery located at 1st & Main Sts with a Continental Oil Company pump & tank. Upon motion of Councilman Meders, seconded by Councilman Bear the request was granted.

Petitions were presented for and against the erection of stables, corrals & feed yards by J.A. Harrison on So. 5th St. Councilman Bear moved, seconded by Councilman Logsdan that a permit be granted to J.A. Harrison to erect a barn feed racks etc. on the tract south of Haggerty's Sub Division on the West side of South Fifth St, providing however that said buildings etc. be not located nearer than 125 feet west of the west property line on Fifth St. Motion carried.

A petition was presented by the residents of Orchard Mesa asking that the proposed new flow line be laid along the main highway so as to serve the residents of Orchard Mesa. The petition was referred to the City Manager.

Councilman Bear moved, seconded by Councilman Ellison that the offer of Frank R. Hall of \$6900.00 for the tract of land lying east of Lincoln Park be accepted. Upon this motion the following vote was cast: Councilmen voting "YEA" Bear, Ellison, Fairley, Logsdan, Meders, Moslander & Bell. Councilmen voting "YEA" None. All the Councilmen voting "YEA" the President declared the motion carried.

Councilman Fairley moved, seconded by Councilman Bear that the bill for \$42.50 to the Colorado Abstract Co. for furnishing abstract to tract east of Lincoln Park be allowed. Motion carried.

L.E. Booth made application to install a root bear counter at the Richard Warren Motor Co. It was moved by Councilman Meders, seconded by Councilman Logsdan that the permit be granted providing that he counter be installed inside the building. Motion carried.

Councilman Fairley moved, seconded by Councilman Meders that the bond of the Strange MaGuire Paving Company covering work in Paving District No. 15 be accepted and approved and that the President of the Council and the City Clerk be instructed and authorized to sign the contract for the construction of said Paving Dist. No. 15 upon approval of the proceedings and the bonds of said district. Upon which motion the following vote was cast: Councilmen voting "YEA" Bear, Ellison, Fairley, Logsdon Meders, Moslander & Bell. All the Councilmen voting "YEA" the President declared the motion carried.

Upon motion duly made and seconded the meeting adjourned.
