Grand Junction, Colorado

The City Council of the City of Grand Junction met in regular session at 7:30 o'clock, P.M. Those present and answering to roll call were: Councilmen Logsden, Bear, Fairley, Meders, Moslander, Ellison and Bell; City Manager Thompson, City Attorney Hinman and City Clerk Bliss; President Bell presiding.

The minutes of the last regular session were read and approved.

The following petition was presented and read by the Clerk:

Grand Junction Colorado

September, 13th, 1926

To the Hon. Mayor and City Council of Grand Junction,

We the undersigned property owners, in the vicinity of seventh street, and Ute ave, do hereby petition your honorable body, against the issuance of a permit or licence for the erection or building of a building or yard for the purpose of wrecking or junking of cars, on the lots on seventh street, between Colorado and Ute Ave in the City of Grand Junction.

Moved by Councilman Meders, seconded by Councilman Bear, that the request of D. L. Cook for permission to construct a frame building and fence for the purpose of wrecking and sale of parts of used automobiles be denied and vote taken as follows: Fairley, yes; Meders, yes; Bear, yes; Moslander, yes; Ellison, yes; Logsden, yes; Bell, yes. Motion carried.

The City Clerk reported there had been no bills filed against Orman Construction Company for combined Sewer District No. 4. Moved by Councilman Meders, seconded by Councilman Logsden, that a warrant be drawn in favor of Orman Construction Co., for \$2,565.96, in settlement of Contractors' estimate No. 6 (Final), on Combined Sewer District No. 4. Vote taken on roll call as follows: Fairley, yes; Meders, yes; Bear, yes; Moslander, yes; Logsden, yes; Ellison, yes; Bell, yes. Motion carried.

Ordinance No. 404, which had been advertised in the Daily Sentinel in its regular issue of August 12, was called up for final passage by motion regularly made by Councilman Bear, seconded by Councilman Meders, and unanimously passed, and was read by the City Clerk. Moved by Councilman Meders, seconded by Councilman Bear, that Ordinance No. 404, concerning the Salary of the City Auditor, be passed and adopted. Vote was taken on roll call, as follows: Fairley, yes; Meders, yes; Bear, yes; Moslander, yes; Ellison, yes; Logsden, yes; Bell, yes. Motion carried.

Petition of remonstrance against paving Chipeta Avenue from First Street to Seventh Street, signed by J. S. Mauzy, Sam Cardman, W. H. Penberthy, and others, was presented and read by the Clerk.

Moved by Councilman Ellison and seconded by Councilman Meders, that the Petition be filed, for the purpose of checking. Motion carried.

Bids for paving proposed Paving District No. 17 were presented and read by the Clerk.

The bid of the Strange-Maguire Paving Company was \$65,592.83 for crushed rock base with black base and Warrenite Bithulithic top, and \$65,703.87 for six inch concrete paving. The bid of Winterburn & Lumsden was \$67,125.29 for crushed rock base, with black base and Warrenite Bithulithic top and \$66,166.90 for six inch concrete paving.

Moved by Councilman Moslander and seconded by Councilman Meders that the bid of The Strange-Maguire Paving Company, using crushed rock base, black base, and Warrenite Bithulithic top be accepted subject to the creation of all or any part of Paving District No. 17, and subject to the approval of the bonds. Vote was taken on roll call, as follows: Fairley, yes; Meders, yes; Bear, yes; Moslander, yes; Logsden, yes; Ellison, yes; Bell, yes. All the Councilmen present voting yes, the President declared the motion carried.

A proposed traffic ordinance was presented and read; Dr. Reed, Dr. Peterson, Dr. Bull and Dr. Sickenberger appeared before the Council in person and protested against limiting their privilege of a special parking space between the hours of 9 o'clock A. M. and 5 o'clock P. M. After considerable discussion and due consideration of the difference provisions of the proposed traffic ordinance, a motion was made by Councilman Meders and seconded by Councilman Bear, that the Traffic Ordinance be passed as an Emergency Ordinance, numbered Ordinance No. 405, and adopted as read, and that it be published once in The Daily Sentinel and that it go into effect from and after publication. Vote was taken on roll call as follows: Fairley, yes; Meders, yes; Bear, yes; Logsden, yes; Ellison, yes; Moslander, yes; Bell, yes; The President declared the motion carried.

Moved by Councilman Moslander and seconded by Councilman Ellison, that City Manager Thompson be instructed to attend the National Convention of City Managers, at Colorado Springs, Sept. 21, 22, and 23, at the expense of the City of Grand Junction, Colorado. Vote was taken on roll call as follows: Fairley, yes; Meders, yes; Bear, yes; Moslander, yes; Logsden, yes; Ellison, yes; Bell, yes. Motion carried.

Moved by Councilman Moslander and seconded by Councilman Bear, that the session of the Council be adjourned to Friday, September 17, 1926, at 7:30 o'clock P. M. Motion carried.
