

Grand Junction, Colo.

March 23rd, 1927.

The City Council of the City of Grand Junction met in regular adjourned session at 7:30 o'clock P.M. with President Bell presiding. Those present and answering at roll call were Councilmen Bear, Meders, Fairley, Ellison, Logsdon, Moslander, Bell. City Attorney Hinman, City Manager Thompson, and City Clerk Niles were present.

Messrs. Gus Johnson, Wm. McKelvie, and Chas. Wallace, County Commissioners, and Scott Heckman, County Attorney, attended the meeting to learn what the Council were going to do regarding the combined City and County Jail building. After discussing the proposition, Councilman Ellison moved, seconded by Councilman Bear, that E. R. Groves, the architect, be requested to submit prospective plans for a combined building to be located on the North side of the alley, on Seventh Street, at a price, not to exceed \$35,000 - \$37,000. Motion carried.

The following proposed People's Ordinance was read:

AN ORDINANCE CONCERNING THE TRANSFER AND CONVEYANCE OF A TRACT OF LAND DESCRIBED AS FOLLOWS: BEGINNING AT A POINT EIGHT HUNDRED SEVENTY (870.0) FEET WEST OF THE CENTER OF THE NORTHWEST QUARTER (NW1/4) OF SECTION 26 TWP ONE SOUTH, RANGE ONE WEST OF THE UTE MERIDIAN: THENCE SOUTH TWO HUNDRED EIGHTY-SIX (286.0) FEET: THENCE WEST TWENTY-FIVE (25.0) FEET: THENCE ALONG A CIRCULAR CURVE RIGHT WITH A RADIUS OF ONE HUNDRED FORTY-THREE (143.0) FEET TO A POINT TWENTY-FIVE (25.0) FEET WEST OF THE PLACE OF BEGINNING: THENCE EAST TWENTY-FIVE (25.0) FEET TO THE PLACE OF BEGINNING: CONTAINING NINE-TENTHS (0.9) ACRE OF LAND, IN MESA COUNTY, COLORADO, TO THE ROBBINS-McMULLIN POST OF THE AMERICAN LEGION FOR CEMETERY PURPOSES.

WHEREAS, The following described tract of land situated in Mesa County, Colorado, to-wit:

Beginning at a point eight hundred seventy (870.0) feet west of the center of the north-west quarter (N.W.1/4) of section 26, Twp. one south, range one west of the Ute Meridian; thence south two hundred eighty-six (286.0) feet; thence west twenty-five (25.0) feet; thence along a circular curve right with a radius of one hundred forty-three (143.0) feet to a point twenty-five (25.0) feet west of the place of beginning; thence east twenty-five (25.0) feet to the place of beginning, containing nine-tenths (0.9) acres of land, is now owned by the City of Grand Junction, Colorado, and is being held by said City for cemetery purposes, and

WHEREAS, The Robbins-McMullin Post of the American Legion is the owner of an adjoining tract which is being held and used by it for cemetery purposes; and,
WHEREAS, The said Robbins-McMullin Post of the American Legion desires to secure the above described tract of land from the City of Grand Junction to more adequately carry out the general plan of beautification and improvement of its cemetery, and to be held and used by it for cemetery purposes and improve and beautify same in accordance with the plans, drawings and specifications of S. R. DeBoer, city planner, now on file in the office of the City Manager of said City:

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO, AND BE IT ORDAINED BY THE ELECTORS OF THE CITY OF GRAND JUNCTION, COLORADO, UPON REFERENDUM BY THE CITY COUNCIL THEREOF:

Section 1. The City Council of the City of Grand Junction, Colorado, by its President and City Clerk, under the seal of said City, are hereby authorized, directed and required to convey by good and sufficient deed of conveyance to the said THE ROBBINS McMULLIN POST OF THE AMERICAN LEGION the tract hereinbefore described, if, within, five years from the date of final passage, adoption and approval hereof, the said The Robbins-McMullin Post of the American Legion shall have completed or caused to have been completed the beautification and improvement of said tract in accordance with the plans and specifications and maps of said S. R. DeBoer, city planner, for the said City.

Section 2. The deed of conveyance to be made by the City of Grand Junction, Colorado, to said The Robbins-McMullin Post of the American Legion shall be subject to the condition, however, in said deed of conveyance to be expressed that the said tract is to be used by said grantee for cemetery purposes, and that all improvements, trees, shrubs, flowers, and lawn thereon shall be properly maintained, irrigated and attended at all times thereafter, and that should said grantee cease to use said tract for cemetery purposes or fail or neglect to properly maintain, irrigate and attend the same, the title to said tract shall revert at the option of said City to the said City.

Councilman Meders moved, seconded by Councilman Logsdon that the proposed ordinance be passed for publication; and that it be referred to the qualified electors of the City of Grand Junction to be voted upon by them at the general election to be held April 5th, 1927, upon which motion the following vote was cast: Councilmen voting "Yea", Councilmen Bear, Meders, Fairley, Moslander, Logsdon, Ellison, Bell. All the Councilmen voting "Yea", the President declared the motion carried.

The Proof of Publication of the proposed ordinance entitled, AN ORDINANCE CONCERNING THE SALARY OF THE JUDGE OF THE MUNICIPAL COURT AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH, WAS READ. Upon motion of Councilman Bear, seconded by Councilman

Logsdon, the proof of publication was accepted and ordered filed. Upon which motion the following vote was cast: Councilmen voting "Yea", Bear, Fairley, Ellison, Logsdon, Bell. Councilmen voting "No", Meders and Moslander. A majority of the Councilmen voting "Yea", the President declared the motion carried and the proof of publication be accepted and filed.

Councilman Bear moved, Councilman Logsdon seconded that the proof of publication be brought up for final passage. Upon which motion the following vote was cast: Councilmen voting "Yea", Bear, Fairley, Ellison, Logsdon, Bell. Councilmen voting "No", Meders, Moslander. A majority of the Councilmen voting "Yea", the President declared the motion carried.

Councilman Bear moved, seconded by Councilman Logsdon that the proposed ordinance entitled, "AN ORDINANCE CONCERNING THE SALARY OF THE JUDGE OF THE MUNICIPAL COURT AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH, be passed and adopted, numbered 417, and published. Upon which motion the following vote was cast: Councilmen voting "Yea", Bear, Fairley, Ellison, Logsdon, Bell. Councilmen voting "No", Meders, Moslander. A majority of the Councilmen voting "Yea", the President declared the motion carried, and the ordinance duly adopted.

The Proof of Publication of the People's Ordinance Entitled "AN ORDINANCE CONTRACTING FOR ELECTRIC CURRENT FOR MUNICIPAL PURPOSES TO BE FURNISHED BY THE PUBLIC SERVICE COMPANY OF COLORADO, ITS SUCCESSORS AND ASSIGNS, TO THE CITY OF GRAND JUNCTION, COLORADO.", was read. Councilman Meders moved, seconded by Councilman Fairley that the proof of publication be accepted and filed. Motion carried.

The report of J. E. Ragan, Auditor, for the six months period ending December 31st, 1927, was presented and read. On motion of Councilman Meders, seconded by Councilman Bear, the report was ordered accepted and filed. Motion carried.

NOTICE OF GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, THE 5th DAY OF APRIL, A. D. 1927.

PUBLIC NOTICE IS HEREBY GIVEN, That a general municipal election will be held on Tuesday, the 5th day of April, A. D. 1927, at the polling places hereinafter designated in the City of Grand Junction, Colorado.

The said general municipal election will be held at the several polling places in the several districts and voting precincts of the City of Grand Junction, in the State aforesaid, as follows:

District A.--City Voting Precinct 9, Polling Place, City Hall.

District B.--City Voting Precinct 10, Polling Place, Western Slope Garage.

District C.--City Voting Precinct 11, Polling Place, Y. M. C. A.

District D.--City Voting Precinct 12, Polling Place, Kane Car Exchange, 701 Main Street.

District E.--City Voting Precinct 16, Polling Place, Christian Church.

Upon the date and at the places designated aforesaid, the polls will be open from the hour of 7 o'clock A. M., to and including, and will be closed at the hour of 7 o'clock P. M. The ballots to be used in voting will be prepared and furnished by the City Clerk to the Judges of the election to be by them furnished to the voters. The election will be held and conducted as nearly as may be, in the manner prescribed by law in the case of elections, for municipal officers. Registration for the said election will take place in the manner now provided by law.

That at said election the following proposed ordinances will be submitted to the qualified electors of the City of Grand Junction for their adoption or rejection:

First. An ordinance entitled "AN ORDINANCE CONTRACTING FOR ELECTRIC CURRENT FOR MUNICIPAL PURPOSES TO BE FURNISHED BY THE PUBLIC SERVICE COMPANY OF COLORADO, ITS SUCCESSORS AND ASSIGNS. TO THE CITY OF GRAND JUNCTION, COLORADO."

Second: An Ordinance Entitled, "AN ORDINANCE CONCERNING THE TRANSFER AND CONVEYANCE OF A TRACT OF LAND DESCRIBED AS FOLLOWS: BEGINNING AT A POINT EIGHT HUNDRED SEVENTY (870.0) FEET WEST OF THE CENTER OF THE NORTHWEST QUARTER (NW1/4) OF SECTION 26, TWP. ONE SOUTH RANGE ONE WEST OF THE UTE MERIDIAN: THENCE SOUTH TWO HUNDRED EIGHTY-SIX (286.0) FEET: THENCE WEST TWENTY-FIVE (25.0) FEET, THENCE ALONG A CIRCULAR CURVE RIGHT WITH A RADIUS OF ONE HUNDRED FORTY-THREE (143) FEET TO A POINT TWENTY-FIVE (25.0) FEET WEST OF THE PLACE OF BEGINNING: THENCE EAST TWENTY-FIVE (25.0) FEET TO THE PLACE OF BEGINNING CONTAINING NINE TENTHS (0.9) ACRE OF LAND IN MESA COUNTY, COLORADO, TO THE ROBBINS-McMULLIN POST OF THE AMERICAN LEGION FOR CEMETERY PURPOSES.

That at said election a member of the City Council will be elected from each of two election districts of said City (i. e. Districts B and C) and one member of the City Council will be elected from the City of Grand Junction at large, each of said Councilmen to be elected for the regular four-year term.
