

Grand Junction, Colo.

June 1st, 1927.

The City Council of the City of Grand Junction met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were: Councilmen Rogers, Hall, Ellison, Penberthy, Meders, Bear, Moslander, City Manager Thompson, and City Clerk Niles. City Attorney Hinman was absent.

The minutes of the regular meeting held May 18th and the regular adjourned meeting held May 20th were read and approved.

Mr. White came before the Council and presented a remonstrance against the proposed paving of Gunnison Avenue from 3rd to 7th Streets. On motion of Councilman Rogers, seconded by Councilman Penberthy and duly carried, the remonstrance was ordered filed and checked.

Petitions for graveling Belford Avenue from 1st to 7th and Rood Avenue from 1st to 2nd were presented. On motion of Councilman Bear, seconded by Councilman Rogers, and duly carried, the petitions were ordered filed and checked.

Gentlemen:

The petition of A. Scott McKinney, respectfully shows that the special assessments and tax sales are erroneous, and should be cancelled, for the following reasons:

WHEREAS, Mr. Mike Hoolihan was erroneously charged \$2.00 for Water Main Assessment on Lot 9, Block 56, for the year 1925. This amount was paid, and should have been carried forward as a full credit for water main for the year 1926. The clerk in charge of this work failed to carry forward the credit of \$1.00, and the lot was sold for the 1926 Water main assessment under tax sale certificate No. 27977.

Your petitioner prays for the cancellation of this tax sale, for the above stated reasons.

There being no further business to come before the meeting, on motion of Councilman Ellison, seconded by Councilman Meders, and duly carried, the meeting adjourned.
