

Grand Junction, Colo.

November, 2nd, 1927.

The City Council of the City of Grand Junction, Colorado met in regular session at 7:30 o'clock P.M. Those present and answering at roll call were Councilmen Hall, Rogers, Penberthy, Meders, Bear, Moslander. Councilman Ellison was absent. City Manager Thompson, City Attorney Hinman, and City Clerk Niles were present.

The minutes of the last regular meeting held October 19th, and of the special meeting held October 26th were read and approved.

Mr. Chas. Rump, Manager of the Public Service Company of Colorado, presented a proposed change in the routing of the busses, giving a twenty-minute service instead of a thirty-minute.

Councilman Penberthy moved, Councilman Meders seconded that the new route submitted by the Public Service Company, be approved. Motion carried.

The Proof of Publication of the Ordinance Entitled AN ORDINANCE REGULATING, THE SALE, STORAGE, DISTRIBUTION, DISCHARGE, AND FIRING OF FIREWORKS AND OTHER PYROTECHNIC DISPLAY was presented. Councilman Meders moved, Councilman Bear seconded that the Proof of Publication be accepted and filed. Motion carried.

The proposed ordinance was then read by the Clerk, and upon motion of Councilman Meders, seconded by Councilman Bear, the proposed ordinance was called up for final passage.

Councilman Meders thereupon moved, seconded by Councilman Bear, that the proposed ordinance entitled AN ORDINANCE REGULATING THE SALE, STORAGE, DISTRIBUTION, DISCHARGE, AND FIRING OF FIREWORKS AND OTHER PYROTECHNIC DISPLAY be passed and adopted, numbered 423, and published. Upon which motion the following vote was cast. Councilmen voting YEA, Hall, Rogers, Penberthy, Meders, Bear, Moslander. Councilmen voting NO, none. All the Councilmen voting YEA the President declared the motion carried.

Councilman Hall moved that W. R. Hinman be instructed to proceed with the defence in the case of Ferrin vs. Decker, Frazier, Gram, and others, and that he be allowed remuneration in the sum of \$150.00 for the completion of the case, provided that the trial does not exceed two days; and that if it should exceed that time, that such further remuneration be given him that would be mutually agreed between the Council and him. Councilman Rogers seconded the motion. The following vote was cast. Councilmen voting YEA, Hall, Rogers, Penberthy, Meders, Bear, Moslander. All the Councilman present voting YEA, the President declared the motion carried.

City Manager Thompson presented the revised budget for the year 1928. After considerable discussion Councilman Rogers, moved, Councilman Bear seconded the motion that the budget be adopted as read. Upon which motion the following vote was cast. Councilmen voting YEA, Hall, Rogers, Penberthy, Meders, Bear, Moslander. Councilmen voting No, none. All the Councilmen present voting YEA, the President declared the motion carried.

There being no further business to come before the meeting, on motion duly made, seconded, and carried, the meeting adjourned.
