November 28th, 1927.

The City Council of the City of Grand Junction, having been duly notified, met in special session at 7:30 o'clock P.M. Those present and answering at roll call were Councilmen Bear, Meders, Ellison, Hall, Rogers, Moslander. Councilman Penberthy was absent. City Manager Thompson, City Attorney Hinman, City Clerk Niles were present.

City Manager Thompson made a report to the Council of the work done under his supervision and the expense incurred in so doing, for cutting weeds and removing rubbish, etc. for the year 1927, under Ordinance #236, as amended.

The following resolution was presented and read:

## RESOLUTION

A RESOLUTION DETERMINING AND ASSESSING THE COST OF THE REMOVAL OF WEEDS, BRUSH AND RUBBISH, UNDER ORDINANCE NO. 236.

WHEREAS, Under Ordinance No. 236 of the City of Grand Junction, passed and adopted May 18, 1915, it is the duty of each and every person, corporation or association owning any lots, tracts or parcels of land within the City of Grand Junction, Colorado, to once each year cut to the ground all weeds and brush, and to remove the same, together with all rubbish of all kinds, from his, its or their said lots, tracts or parcels of land; and also to out closely all weeds and brush and remove the same, together with all rubbish of all kinds, from the alleys abutting behind to the middle thereof and from the sidewalk areas, including the parking, abutting in front of all said lots, tracts or parcels of land within said City; and that said duties shall be performed between the 15th day of July and the first day of August of each and every year; and

WHEREAS, Pursuant to said Ordinance, the City Clerk of said City did, within the time provided in said Ordinance, duly and regularly publish a notice notifying all owners of the property, without naming them, of their duty to cut the said weeds and brush and to remove same, together with their rubbish, from their property and from the streets and alleys, as in said Ordinance provided; and that in default thereof, the work would be done under orders of the City Council, and the cost thereof, together with the penalties provided in said Ordinance, would be charged to the respective lots, tracts or parcels of land, and

WHEREAS, The hereinafter described owner or owners of certain tracts and parcels of land hereinafter described failed to cut and remove the weeds, brush and rubbish as therein provided, and within the time and in the manner provided by said notice, and report thereof was made to the City Council, as provided in said Ordinance, and said Council did thereupon order such City Manager

to cut or cause to be cut and removed from such lots, alleys and sidewalk areas all of such weeds, brush and rubbish, and

WHEREAS, The City Manager of said City has made and filed with the said Council a report in writing, containing a clear statement of the work done by him or under his supervision, and the expenses incurred in so doing, showing the cost of such work and the cost for each lot or parcel of land; and said report has been duly considered by said Council of the City of Grand Junction aforesaid.

NOW, THEREFORE, Be it resolved by the City Council of the City of Grand Junction:

Section 1. That the Council finds and so determines that all matters and things prerequisite to the assessment of the cost of cutting weeds and removing brush for the year 1927 have been fully done and performed in accordance with Ordinance No. 236 of said City, passed and adopted May 18, 1915.

Section 2. That, according to the report of the City Manager, it appears and the Council so determines the fact to be that the several amounts properly chargeable against the various delinquent owners and against each lot, parcel or other tract of land, on account of the cutting and removal of weeds, brush and rubbish by the City of Grand Junction for the year 1927, are as follows, to-wit:

Section 3. That, under and by virtue of the authority conferred in said Ordinance No. 236 aforesaid, the several amounts set forth and described in Section 2 above are hereby assessed as proper amounts chargeable against the delinquent owners above described and the several lots, parcels and other tracts of land therein described, for the purposes aforesaid.

To which assessments shall be added five per centum thereof for the costs of inspection and other incidental costs.

Section 4. That the City Clerk of the City of Grand Junction shall, as soon as may be, send by mail, addressed to the owner or owners of each lot or tract of land hereinbefore described at the reputed postoffice address of such owner or owners, a notice of such assessment, which notice shall contain a description of the lots or parcels of land, the name of the owner or owners and the amount of the assessment.

Section 5. It shall be the duty of the owner or owners to pay the assessments hereinbefore described within twenty days after the mailing of the notice herein provided, and in case of his, its or their failure so to do, he, it or they shall be liable personally for the amount of the assessment; and the same shall be a lien upon the respective lots or parcels of land from the time of such assessment.

Section 6. In case the owner shall fail to pay such assessment within twenty days after notice has been mailed to him, it or them, as provided herein, it shall be the duty of the City Clerk to certify the amount of the assessment and assessments herein made to the County Treasurer of Mesa County, or other officer of said county having custody of the tax list at the time of such certification, to be by him placed upon the tax list for the current year, and to be collected in the same manner as other taxes are collected, with 10% penalty thereon to defray the cost of collection; and all of laws of the State of Colorado for the assessment and collection of general taxes, including the laws for the sale of property for taxes and the redemption thereof, shall apply to and have full effect for the collection of all such assessments.

Councilman Meders moved, Councilman Rogers seconded the motion that the resolution be passed and adopted as read. Upon which motion the following vote was cast: Councilmen voting YEA, Meders, Bear, Rogers, Hall, Ellison, Moslander. City Manager Thompson stated that the Public Service Company of Colorado had made a proposition in which the City was to furnish red and green globes for the White Way lights during the holiday season. The Public Service Co. agreeing to make all replacements, and take care of putting on and taking off the globes and storing them.

Councilman Meders moved, Councilman Hall seconded the motion that the proposal of the Public Service Company of Colorado for the installation of red and green globes for the holiday season for the entire White Way system be accepted, provided the various provisions thereof be presented to the Council in writing, in form ready for their acceptance. Councilmen voting YEA on this motion: Meders, Hall, Rogers, Bear, Ellison, Moslander. Councilmen voting NO, None. All the Councilmen present voting YEA, the President declared the motion carried.

The matter of the City installing a drinking fountain in the Chamber of Commerce building was brought up and discussed.

Councilman Rogers Moved, Councilman Ellison seconded the motion that a drinking fountain be put in the Chamber of Commerce building by the City and that the same should be paid out of the Contingent fund. Upon which motion the following vote was cast: Councilmen voting YEA, Meders, Bear, Rogers, Hall Ellison,

Moslander. Councilmen voting No, None. All the Councilmen present voting YEA, the President declared the motion carried.

Councilman Rogers moved, Councilman Bear seconded the motion that the City Manager and City Clerk be authorized to pay out of the water working fund, an additional \$600.00 for interest in the case of the Grand Valley National Bank, vs. the Orman Construction Co, and others, Upon which motion the following vote was cast: Councilmen voting YEA, Meders, Bear, Rogers, Hall, Ellison, Moslander. Councilmen voting NO, None. All the Councilmen present voting YEA, the President declared the motion carried.

The proposed water budget for 1928 was brought up and discussed. Councilman Hall moved, Councilman Meders seconded the motion that the water budget, as submitted, be adopted. Upon which motion the following vote was cast: Councilmen voting YEA, Meders, Bear, Rogers, Hall, Ellison, Moslander. Councilmen voting NO, none. All the Councilmen voting YEA, the President declared the motion carried.

There being no further business to come before the meeting, on motion duly made, seconded, and carried, the meeting adjourned.
