Grand Junction, Colorado

February 1, 1928

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were: Councilmen Penberthy, Meders, Bear, Rogers, Hall, Ellison, Moslander. City Manager Thompson, City Attorney Hinman, City Clerk Niles, were present.

The minutes of the regular meeting held January 18th were read and approved.

White Way Lights - 7th Street between Main and Grand:

Mr. Morgan and Mr. Boller were present and presented a petition requesting that White Way lights be installed on Seventh Street between Main Street and Grand Avenue. The City to pay one-half the cost of installation and the property owners the other half of the cost.

Councilman Penberthy moved, Councilman Meders seconded the motion that the petition be accepted and filed, and the matter tabled until the next regular meeting. Motion carried.

Public Service Company Light Rates:

Mr. Carl Luscombe, representing the Public Service Company of Colorado, presented a revised schedule of rates for electric service. President Moslander appointed Councilmen Ellison, Hall, Rogers, and City Manager Thompson to meet with the Public Service Company regarding this proposed change of rates.

Arkansas River Water Diversion:

The following resolution was presented and read:

WHEREAS, The Public Service Company of Colorado has applied jointly to the Colorado Public Utilities Commission and the Federal Power Commission for leave to divert three hundred second feet of water from the Arkansas River above the Royal Gorge, and

WHEREAS, the records of the Colorado State Engineer's office show beyond doubt, that for considerable portions of each year, such diversion would leave the stream dry, or nearly so, and thereby detract materially from the scenic attraction of the Royal Gorge,

NOW THEREFORE BE IT RESOLVED, That after further consideration, the City Council of the City of Grand Junction rescind its action of January 18th and vigorously protest the granting of this, or any like application for such diversion, of the waters of the Arkansas River in the vicinity of the Royal Gorge, and that a copy of this resolution be forwarded by the City Clerk to the

Colorado Public Utilities Commission and to the Federal Power Commission.

After discussion by the Councilmen and by Attorney Sternberg, representing the Public Service Company of Colorado, and Attorney Smith, representing the D.R.G.W. Ry. Co., Councilman Rogers moved and Councilman Bear seconded the motion that the resolution as read, be passed and adopted. Upon which motion the following vote was cast: Councilmen voting YEA, Penberthy, Meders, Bear, Rogers, Ellison. Councilmen voting No, Moslander, Hall. A majority of the Councilmen voting YEA, the President declared the motion carried.

The Proof of Publication of the Ordinance entitled "AN ORDINANCE AMENDING SECTIONS 4, 5, and 6 OF ORDINANCE NO. 212, PASSED AND ADOPTED AUGUST 26, 1913, ENTITLED "AN ORDINANCE TO PROVIDE FOR ESTABLISHING AND MAINTAINING PERMANENT REGISTRATION LISTS OF THE QUALIFIED ELECTORS IN THE ELECTION PRECINCTS WITHIN THE CITY OF GRAND JUNCTION, FOR USE IN MUNICIPAL ELECTIONS: TO PROVIDE FOR PUNISHING ALL VIOLATIONS THEREOF AND FOR THE APPOINTMENT OF JUDGES FOR SPECIAL ELECTIONS WHERE NO CANDIDATES ARE TO BE VOTED FOR", was presented. Ordinance No 428:

Councilman Meders thereupon moved, seconded by Councilman Bear that the proposed ordinance entitled "AN ORDINANCE AMENDING SECTIONS 4, 5, and 6, of ORDINANCE NO. 212, PASSED AND ADOPTED AUGUST 26, 1913, ENTITLED, "AN ORDINANCE TO PROVIDE FOR ESTABLISHING AND MAINTAINING PERMANENT REGISTRATION LISTS OF QUALIFIED ELECTORS IN THE ELECTION PRECINCTS WITHIN THE CITY OF GRAND JUNCTION, FOR USE IN MUNICIPAL ELECTIONS: TO PROVIDE FOR PUNISHING ALL VIOLATIONS THEREOF AND FOR THE APPOINTMENT OF JUDGES FOR SPECIAL ELECTIONS WHERE NO CANDIDATES ARE TO BE VOTED FOR", be passed and adopted, numbered 428, and published. Councilman Meders moved, Councilman Rogers seconded the motion that the Proof of Publication be accepted and filed.

Ordinance No. 429:

The proposed ordinance was then read by the Clerk, and upon motion of Councilman Meders, seconded by Councilman Bear, it was called up for final passage. Motion carried.

Councilman Meders thereupon moved, Councilman Bear seconded the motion that the proposed ordinance entitled "AN ORDINANCE AMENDING SECTIONS 1, 4, and 5 of ORDINANCE NO. 236, PASSED AND ADOPTED MAY 18, 1915, AND ENTITLED, "AN ORDINANCE CONCERNING THE CUTTING OF WEEDS" be passed and adopted, numbered 429, and published. Upon which motion the following vote was cast. Councilmen voting YEA, Penberthy, Meders, Bear, Rogers, Hall, Ellison, Moslander. All the Councilmen voting YEA, the President declared the motion carried.

The Proof of Publication of the Ordinance entitled, "AN ORDINANCE CONCERNING LARCENY AND THE BUYING OR RECEIVING GOODS OR OTHER THINGS OBTAINED BY LARCENY, BURGLARY OR ROBBERY, AND PROVIDING A PUNISHMENT THEREFOR," was presented. Councilman Bear moved, Councilman Penberthy seconded the motion that the Proof of Publication be accepted and filed.

Ordinance No. 430:

The proposed ordinance was then read by the Clerk, and upon motion of Councilman Meders, seconded by Councilman Ellison, it was called up for final passage. Motion carried.

Councilman Bear thereupon moved, seconded by Councilman Meders, that the proposed ordinance entitled, "AN ORDINANCE CONCERNING LARCENY AND THE BUYING OR RECEIVING GOODS OR OTHER THINGS OBTAINED BY LARCENY, BURGLARY OR ROBBERY, AND PROVIDING A PUNISHMENT THEREFOR", be passed and adopted, numbered 430, and published. Upon which motion the following vote was cast. Councilmen voting YEA, Penberthy, Meders, Bear, Rogers, Hall, Ellison, Moslander. All the Councilmen voting YEA, the President declared the motion carried.

Sell Lots Owned by City:

Councilman Penberthy moved, Councilman Meders seconded the motion that the City of Grand Junction sell lots #1, 2, 3, 4, Block 68, in accordance with People's Ordinance No. 14, passed and adopted June 4th, 1924, and with 1927 taxes and assessments, and all previous taxes and assessments paid. Purchaser to assume the 1928 general taxes and special assessments. Upon which motion the following vote was cast. Councilmen voting YEA, Penberthy, Meders, Bear, Rogers, Hall, Ellison, Moslander.
