The City Council of the City of Grand Junction having been duly notified met in special session on June 18th at 7:30 o'clock P.M. for the purpose of considering a special appropriation ordinance for the purchase and installation of a sand and gravel plant and crusher. Those present and answering at roll call were President Moslander, Councilman Ellison, Hall, Meders, Penberthy, Rogers, City Attorney Hinman and City Manager Thompson.

It was regularly moved by Councilman Rogers, seconded by Councilman Penberthy that on account of the absence of City Clerk Niles that W. L. Sackett be appointed as City Clerk Pro-tem. Motion carried.

Special Appropriation for Purchase of Gravel Plant:

The following proposed ordinance was introduced and read by the clerk pro-tem:

ORDINANCE NO.

AN ORDINANCE PROVIDING AN APPROPRIATION FOR THE PURCHASE AND INSTALLATION OF A SAND AND GRAVEL PLANT AND CRUSHER.

WHEREAS, Since the date of the adoption of the annual appropriation ordinance for the fiscal year ending December 31, 1928, unforeseen contingencies have arisen in that since said date petitions have been presented to the City Council of the City of Grand Junction to create a local improvement district; and pursuant thereto, the said City Council has declared its intention to create a paving district in said city, to be known and designated as Paving Dist. #20, and has determined that said proposed improvements can be efficiently made by the city, and that in making said improvements a great quantity of sand and crushed gravel is necessary and will be required by said city; and

WHEREAS, The said city has experienced great difficulty in obtaining crushed gravel and sand of proper quality and quantity from others when and as required in making like improvements in the past, and has suffered damage, inconvenience, loss and delay from such source in making like improvements in the past; and

WHEREAS, Said plant and crusher can be utilized and used to great advantage by said city in the performance of other city work, including sidewalk construction and reconstruction, street surfacing, alley and intersection work, and cement work of all kinds, wherein sand and or gravel is required, both in emergency repairs and in regular construction work required by said city; and WHEREAS, It is deemed economical and for the best interests of the city to install and operate its own sand and gravel plant and crusher, and it is further deemed necessary to meet the unforeseen contingency of making the improvements contemplated in said Paving District No. 20 that said sand and gravel plant and crusher be immediately purchased and installed and placed in operation to provide sand and gravel for such improvements:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

Section 1. That for the purpose of purchasing and installing a sand and gravel plant and crusher, there is hereby appropriated out of unappropriated funds of said city the sum of \$9524.75.
