

Grand Junction, Colorado

November 7, 1928

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were Councilmen Moslander, Penberthy, Meders, Bear, Rogers, Hall, Ellison. City Manager Thompson, City Attorney Hinman, and City Clerk Niles were present.

The minutes of the regular meeting of the Council held October 17th, and the special meetings held October 25th and October 31st were read and approved.

The Proof of Publication of the Ordinance entitled, AN ORDINANCE REGULATING THE OPERATION OF AIRCRAFT OVER AND IN THE CITY OF GRAND JUNCTION AND THE TERRITORY SUBJECT TO ITS JURISDICTION, was presented and read. It was moved by Councilman Meders and seconded by Councilman Bear, that the Proof of Publication be accepted and filed. Motion carried.

The proposed ordinance was then read, and upon motion of Councilman Meders, seconded by Councilman Bear, and duly carried, was called up for final passage.

Councilman Bear thereupon moved, seconded by Councilman Meders, that the ordinance entitled "AN ORDINANCE REGULATING THE OPERATION OF AIRCRAFT OVER AND IN THE CITY OF GRAND JUNCTION AND THE TERRITORY SUBJECT TO ITS JURISDICTION be passed and adopted, numbered 437, and published. Upon which motion the following vote was cast: Councilmen voting AYE, Penberthy, Meders, Bear, Rogers, Hall, Ellison, Moslander. All the Councilmen voting AYE, the President declared the motion carried.

Sunday billiards

A letter from the W. C. T. U. expressing their appreciation of the action taken by the City Council in regard to turning down the petition to open the billiard rooms throughout the City on Sunday, was read, and ordered filed.

D.R.G. Trains 15 & 16

A letter from the Public Utilities Commission of the State of Colorado, regarding the petition of the D. & R. G. W. R. R. Co. to discontinue operation of passenger trains 15 and 16 west of Leadville, Colorado, was presented and read.

It was moved by Councilman Hall and seconded by Councilman Rogers, that the President of the Council appoint a committee to confer with the Chamber of Commerce or any other local parties

with a view to expressing the opinion of the City Council on the matter of removing trains No. 15 and 16. Motion carried. President Moslander appointed Councilman Ellison and Councilman Penberthy to serve as the committee.

There being no further business to come before the meeting, on motion of Councilman Rogers, seconded by Councilman Hall, and duly carried, the meeting adjourned.
