The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were: Councilmen Ellison, Hall, Rogers, Penberthy, Meders, Bear, Moslander. City Manager Thompson, City Attorney Hinman, and City Clerk Niles were present.

The minutes of the regular meeting held February 6th were read and approved.

Abandon Tourist Park and improve Golf Course.

A committee representing the Municipal Golf Club appeared before the Council in regard to abandoning the Tourist Park, and making certain improvements in the Golf Course. After considerable discussion, it was moved by Councilman Hall and seconded by Councilman Rogers that the Municipal Tourist Park be abandoned. Upon which motion the following vote was cast: Councilmen voting YEA, Ellison, Hall, Rogers, Meders, Bear, Penberthy, Moslander. All the Councilmen voting YEA, the President declared the motion carried.

A proposed ordinance entitled "AN ORDINANCE AMENDING SECTION 6 OF ORDINANCE NO. 432, PASSED AND ADOPTED MAY 2nd, 1928., was introduced and read. It was moved by Councilman Hall and seconded by Councilman Meders that the proposed ordinance be passed for publication. Motion carried.

Permit to install curb pump.

The Cities Oil Co. presented a written request that they be allowed to install a curb gas pump at 518 Colorado Avenue. Councilman Ellison moved and Councilman Penberthy seconded the motion that the permit be denied. Motion carried.

It was moved by Councilman Penberthy and seconded by Councilman Meders that the City Manager be instructed to get bids on one mile of twenty-inch cast iron pipe for the flow line. Motion carried.

There being no further business to come before the meeting, on motion of Councilman Penberthy, and seconded by Councilman Meders, the meeting adjourned.
