

Grand Junction, Colorado.

September 4, 1929

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were Councilmen Penberthy, Glassford, Bear, Hirons, Hall, Sievert, Rogers. City Manager Thompson, City Attorney Hinman, and City Clerk Niles were present.

The minutes of the regular meeting held August 21st, were read and approved.

Mr. C. P. McCary appeared before the Council and protested against the proposed alley paving in the alley between fourth and Sixth Streets and Colorado and Ute. He also presented a written protest which had been signed by a number of property owners along this alley. Protests were also filed against the alley between White and Rood from Sixth to Seventh Streets. Councilman Bear moved and Councilman Glassford seconded the motion that the petitions be laid over until Saturday evening for consideration, Motion carried.

Gentlemen:

Barbara Caravello is the owner of Lots 31 and 23, Block 3, Crawfords Subdivision. Her husband, Sam Caravello, sent to the County Treasurer's office funds sufficient to pay the special and general taxes due in 1929.

Through an error in the Assessor's office, Sam Caravello is assessed on the tax rolls with Lots 14 and 15, Block 6,

Carpenters Subdivision No. 2. These lots had been sold for taxes for the years 1926 and 1927, and for the Water Main of 1923 and subsequent years.

The County Treasurer's office executed a redemption certificate on Tax Sale Certificates Nos. 24739 and 24740 covering 1923 and subsequent years of Water Main taxes. The amount paid was as follows:

Sam Caravello is not now, nor never was, the owner of Lots 14 and 15, Block 6, Carp. Sub. #2, and has not the right of redemption on these lots. He has paid \$21.26 in redemption of tax sales on two vacant lots, when his intention was to pay the taxes for the year 1928 and specials of 1929 on his home.

Your petitioner prays for an order from your honorable council, directing the cancellation of this redemption certificate, and a restoration of these unpaid taxes on the records; or an order to make a new sale on the above lots for the year 1923 with subsequent years endorsed.

All the Councilmen voting YEA, the President declared the motion carried.

Attorney Helman appeared before the Council on behalf of the Avalon Theater Co., and concerning the sewer connection at the Avalon Theater, the theater building basement having been flooded several times lately. Mr. Thompson, City Manager explained the City Council the history of the trouble at the Avalon theater, and also mentioned plans which he has in mind for remedying the situation.

Councilman Hall moved and Councilman Hirons seconded the motion that the City Manager, aided by the City Attorney, communicate in writing with the Attorneys for the Avalon Theater, making such suggestions as may occur to them under the

circumstances, to see if some arrangement can not be made regarding the Avalon sewer stoppage. Motion carried.
