Mr. Thompson explained that he did not have the new building code ready, as yet, and did not need a Building Inspector until the code was ready. interest on daily bank balances reduced

Please be advised that after December 31, 1929, the undersigned banks will be pleased to continue the practice of paying you interest on the daily balance, as we have done in the past, at the rate of 2% per annum, payable monthly, but, that after said date, we shall deduct one-half of one per cent to partially meet the cost of furnishing bond.

You will readily see that this deduction will not quite meet said cost, because, for the greater portion of the year, we furnish bonds in excess of the amounts carried on deposit.

This arrangement which we propose will bring our practice with regard to the City's deposit into line with that which we have been following for the past year with regard to the handling of County funds.

An Ordinance Entitled "THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF GRAND JUNCTION, COLORADO, PROVIDING FOR THE EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION FOR THE FISCAL YEAR BEGINNING JANUARY 1st, A. D. 1930 AND ENDING DECEMBER 31st, A. D. 1930," AND DECLARING AN EMERGENCY, was presented and read.

Councilman Sievert moved and Councilman Hirons seconded the motion that the emergency ordinance entitled, THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF GRAND JUNCTION, COLORADO, PROVIDING FOR THE EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION FOR THE FISCAL YEAR BEGINNING JANUARY 1st, A. D. 1930 AND ENDING DECEMBER 31st, A. D. 1930, AND DECLARING AN EMERGENCY", be passed as an emergency ordinance, numbered 456, and published. Upon which motion the following vote was cast:
