The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were: Councilmen Penberthy, Bear, Hirons, Hall, Sievert, Rogers. Councilman Glassford was absent. City Manager Thompson, City Attorney Hinman, and City Clerk Niles were present.

The minutes of the regular meeting held December 18th and the regular adjourned meeting held December 27th were read and approved.

The Proof of Publication of the Ordinance entitled "AN ORDINANCE CONCERNING SALARIES" was presented. It was moved by Councilman Bear and seconded by Councilman Penberthy that the Proof of Publication be accepted and filed. Motion carried.

The proposed ordinance was then read.

Councilman Hall moved and Councilman Hirons seconded the motion that the ordinance be called up for final passage. Motion carried.

Ord. #457

Councilman Bear moved and Councilman Sievert seconded the motion that the ordinance entitled "AN ORDINANCE CONCERNING SALARIES", be passed and adopted, numbered 457, and published. Upon which motion the following vote was cast: Councilmen voting YEA - Penberthy, Bear, Hirons, Hall, Sievert, Rogers. Councilmen voting NO - None. All the Councilmen present voting YEA, the President declared the motion carried.

Prop. Ord. Re misdemeanor

A proposed ordinance entitled "AN ORDINANCE AMENDING SECTION 1 OF ARTICLE 2 OF ORDINANCE NO. 83, PASSED AND ADOPTED JUNE 30, 1899, ENTITLED "AN ORDINANCE CONCERNING OFFENSES IN THE NATURE OF MISDEMEANORS AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF", AS SUBSEQUENTLY AMENDED BY ORDINANCE NO. 306", was presented and read.

Councilman Penberthy moved and Councilman Hirons seconded the motion that the proposed ordinance be passed for publication. Motion carried.

Advt. For bids on Alley Pav. Dist. #2

Councilman Hirons moved and Councilman Hall seconded the motion that the City Clerk be instructed to call for sealed bids on the bonds of Alley Paving District No. 2, in the amount of \$12,000.00.

All bids to be filed prior to January 15th, 1930, at 7:30 o'clock P. M. The City reserving the right to reject any and all bids. Motion carried.

City Attorney

The bond of Mr. Jas. Broadhead, Electrician, having been approved as to form by the City Attorney was presented. Councilman Penberthy moved and Councilman Hall seconded the motion that the bond be accepted and filed.

Radio inter.

Radio interference from electrical appliances was brought up and discussed for some time. Councilman Hall moved and Councilman Sievert seconded the motion that the President of the Council, Mr. Rogers, City Manager, Thompson, and Mr. Penberthy, be designated as a committee to investigate this matter fully, and draw up a satisfactory ordinance covering same, and submit their report at a later meeting. Motion carried.

There being no further business to come before the meeting, on motion of Councilman Penberthy, seconded by Councilman Hall, the meeting adjourned to meet again at the call of the President.
