

Grand Junction, Colorado

October 15, 1930

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were: Councilmen Penberthy, Glassford, Bear, Hirons, Hall, Sievert, Rogers. City Manager Soderstrum, City Attorney Adams, and City Clerk Tomlinson were present.

The minutes of the meeting held October 1st were read and approved.

N. 12th imp.

Some consideration was given to the proposed improvements to North Twelfth Street from Gunnison Avenue to North Avenue. City Manager, Soderstrum reported that he had had Twelfth Street cross-sectioned and plotted in reference to grades. He estimated that it would cost \$1,000.00 to do the necessary excavating and replacing of gravel to form a good foundation for the Utah rock top.

Prop. Ord. Min. golf crse.

A proposed Ordinance entitled "AN ORDINANCE PROVIDING FOR THE PAYMENT OF A LICENSE FOR THE OPERATING OR MAINTAINING OF MINIATURE GOLF LINKS IN THE CITY OF GRAND JUNCTION, OPERATED OR MAINTAINED FOR PROFIT" was introduced. It was moved by Councilman Penberthy and seconded by Councilman Hall that the proposed ordinance be passed for publication. Motion carried.

Prop. Ord. Licensing cement contractors

A proposed Ordinance entitled "AN ORDINANCE LICENSING AND REGULATING THE BUSINESS OF CONTRACTORS FOR BUILDING CEMENT SIDEWALKS IN THE CITY OF GRAND JUNCTION, COLORADO", was presented. It was moved by Councilman Glassford and seconded by Councilman Hirons that the proposed ordinance be passed for publication. Motion carried.

Prop. Ord. Prevent fire hazards

A proposed Ordinance entitled, "AN ORDINANCE TO PREVENT FIRE HAZARDS BY REGULATING THE USE OF ARTIFICIAL LIGHTING APPARATUS IN HOME PORTRAIT PHOTOGRAPHY IN THE CITY OF GRAND JUNCTION", was presented. It was moved by Councilman Hirons and seconded by Councilman Bear that the ordinance be passed for publication. Motion carried.

Cities Oil Co. request to extend driveway

A request from the Cities Oil Company asking to be allowed to

extend the driveway which leads into their filling station from the Street, ten feet to the South was presented. A sketch showing the proposed extension accompanied the request.

It was moved by Councilman Glassford and seconded by Councilman Penberthy that the Cities Oil Company be granted permission to extend their driveway ten feet to the South, making the total width of the driveway 43 feet. Motion carried.

Approaches to filling stations be limited as much as possible 12 feet or wider submitted to Council

Councilman Hall moved and Councilman Penberthy seconded the motion that it be the sense of the Council that approaches to filling stations and other similar places of business where the curb is taken out, be restricted in width as much as possible. Applications for all such driveways exceeding twelve feet in width, accompanied by a sketch of the proposed change, shall be submitted to the City Council for their approval. Motion carried.

1931 budget

Consideration was given to various items which are to be included in the 1931 budget.

Councilman Hirons moved and Councilman Bear seconded the motion that the meeting adjourn until Monday evening, October 19th, at 7:30 o'clock P. M.
