

Grand Junction, Colorado

November 5, 1930

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were Councilmen Penberthy, Glassford, Bear, Hirons, Hall, Sievert, Rogers. City Manager Soderstrum, City Attorney Adams, and City Clerk Tomlinson were present.

The minutes of the regular meeting held October 15th and the regular adjourned meetings held October 19th and 27th were read and approved.

The Proof of Publication of the Ordinance entitled "AN ORDINANCE TO PREVENT FIRE HAZARDS BY REGULATING THE USE OF ARTIFICIAL LIGHTING APPARATUS IN HOME PORTRAIT PHOTOGRAPHY IN THE CITY OF GRAND JUNCTION", was presented. It was moved by Councilman Glassford and seconded by Councilman Hirons that the Proof of Publication be accepted and filed. Motion carried.

Councilman Hirons moved and Councilman Bear seconded the motion that the ordinance entitled "AN ORDINANCE TO PREVENT FIRE HAZARDS BY REGULATING THE USE OF ARTIFICIAL LIGHTING APPARATUS IN HOME PORTRAIT PHOTOGRAPHY IN THE CITY OF GRAND JUNCTION", be amended by inserting the following "TO BEGIN BUSINESS NOT LESS, HOWEVER, THAN THIRTY DAYS FROM AND AFTER APPLYING FOR SAID PERMIT WHICH SHALL BE PERSONAL TO THE APPLICANT", making the last part of Section 3, read as follows:

Upon the filing of such application and bond and the approval of such bond by the City Council of said City, the license shall be issued by said Clerk to the applicant to begin business not less, however, than thirty days from and after applying for said permit which shall be personal to the applicant, and shall expire on December 31st next thereafter, and no agent or employee shall carry on such work unless his name appears on such application or until a separate permit is obtained for such agent or employee. Any such permit may be renewed on December 31st of each year by renewing the bond and paying an annual license fee of \$5.00.

Upon which motion the following vote was cast: Councilmen voting YEA - Penberthy, Glassford, Bear, Hirons, Hall, Sievert, Glassford. Councilmen voting No - None. All the Councilmen voting YEA, the President declared the motion carried.

The ordinance was then read as amended and upon motion of Councilman Sievert, seconded by Councilman Bear, it was ordered up for final passage. Motion carried.

Councilman Sievert moved and Councilman Glassford seconded the motion that the Ordinance entitled "AN ORDINANCE TO PREVENT FIRE HAZARDS BY REGULATING THE USE OF ARTIFICIAL LIGHTING APPARATUS IN HOME PORTRAIT PHOTOGRAPHY IN THE CITY OF GRAND JUNCTION, be passed and adopted as amended, numbered 474, and published. Councilman Penberthy moved and Councilman Bear seconded the motion that the Ordinance entitled "AN ORDINANCE LICENSING AND REGULATING THE BUSINESS OF CONTRACTORS FOR BUILDING CEMENT SIDEWALKS IN THE CITY OF GRAND JUNCTION, COLORADO", be amended by inserting the words "AFTER DECEMBER 31st, 1930", after the words "CITY OF GRAND JUNCTION, COLORADO" in the fourth line of Section 1. Upon which motion the following vote was cast: Councilmen voting YEA, Penberthy, Bear, Glassford, Hirons, Hall, Sievert, Rogers. All of the Councilmen voting YEA, the President declared the motion carried.

The ordinance was then read as amended, and upon motion of Councilman Hirons seconded by Councilman Penberthy, was brought up for final passage. Motion carried.

Councilman Hall moved and Councilman Hirons seconded the motion that the Ordinance entitled "AN ORDINANCE LICENSING AND REGULATING THE BUSINESS OF CONTRACTORS FOR BUILDING CEMENT SIDEWALKS IN THE CITY OF GRAND JUNCTION, COLORADO," be passed as amended, numbered 475 and published. Upon which motion the following vote was cast: Councilmen voting YEA - Penberthy, Bear, Glassford, Hirons, Hall, Sievert, Rogers. Councilmen voting NO - None. All of the Councilmen voting YEA, the President declared the motion carried.

The Proof of Publication to the Ordinance entitled "AN ORDINANCE PROVIDING FOR THE PAYMENT OF THE OPERATING OR MAINTAINING OF MINIATURE GOLF LINKS IN THE CITY OF GRAND JUNCTION, COLORADO, OPERATED AND MAINTAINED FOR PROFIT" was introduced. It was moved by Councilman Penberthy and seconded by Councilman Glassford that the Proof of Publication be accepted and filed. Motion carried.

Councilman Hall moved and Councilman Bear seconded the motion that the Ordinance be brought up for final passage. Motion carried.

It was then moved by Councilman Penberthy and seconded by Councilman Bear that the ordinance entitled "AN ORDINANCE PROVIDING FOR THE PAYMENT OF A LICENSE FOR THE OPERATING OR MAINTAINING OF MINIATURE GOLF LINKS IN THE CITY OF GRAND JUNCTION, COLORADO, OPERATED OR MAINTAINED FOR PROFIT" be passed and adopted, numbered 476 and published. Upon which motion the following vote was cast: Councilmen voting YEA, Penberthy, Glassford, Bear, Hirons, Hall, Sievert, Rogers. Councilmen voting NO - None. All of the Councilmen voting YEA, the President declared the motion carried.

The following resolution was presented and read:

RESOLUTION

A RESOLUTION DETERMINING AND ASSESSING THE COST OF THE REMOVAL OF WEEDS, BRUSH AND RUBBISH, UNDER ORDINANCE NO. 236, AS AMENDED.

WHEREAS, Under Ordinance No. 236 of the City of Grand Junction, passed and adopted May 18, 1915, as amended by Ordinance No. 286 and 429, it is the duty of each and every person, corporation or association owning any lots, tracts or parcels of land within the City of Grand Junction, Colorado, to once each year cut to the ground all weeds and brush, and to remove the same, together with all rubbish of all kinds, from his, its or their said lots, tracts or parcels of land; and also to cut closely all weeds and brush and remove the same, together with all rubbish of all kinds, from the alleys abutting behind to the middle thereof and from the sidewalk areas, including the parking, abutting in front of said lots, tracts or parcels of land within said City; and that said duties shall be performed between the first day of July and the fifteenth day of July of each and every year; and

WHEREAS, Pursuant to said Ordinance, as so amended, the City Clerk of said City did, within the time provided therein, duly and regularly publish a notice notifying all owners of the property, without naming them, of their duty to cut the said weeds and brush and to remove same, together with their rubbish, from their property and from the streets and alleys, as in said Ordinance provided; and that in default thereof, the work would be done under orders of the City Manager, and the cost thereof, together with the penalties provided in said Ordinance, would be charged to the respective lots, tracts or parcels of land; and

WHEREAS, The hereinafter described owner or owners of certain tracts and parcels of land hereinafter described failed to cut and

remove the weeds, brush, and rubbish as therein provided, and within the time and in the manner provided by said notice, the said City Manager did thereupon proceed as soon as practicable thereafter to have such work done and to cut or cause to be cut and removed from such lots, alleys and sidewalk areas all of such weeds, brush, and rubbish; and

WHEREAS, The City Manager of said City has made and filed with the said Council a report in writing, containing a clear statement of the work done by him or under his supervision, and the expenses incurred in so doing, showing the cost of such work and the cost for each lot or parcel of land, so that the Council may determine the cost of such work therefrom; and said report has been duly considered by said Council of the City of Grand Junction aforesaid.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

SECTION 1. That the Council finds and so determines that all matters and things prerequisite to the assessment of the cost of cutting weeds and removing brush for the year 1929 have been fully done and performed in accordance with Ordinance No. 236 of said City, passed and adopted May 18, 1915, as amended.

SECTION 2. That, according to the report of the City Manager, it appears and the Council so determines the fact to be that the several amounts properly chargeable against the various delinquent owners and against each lot, parcel or other tract of land, on account of the cutting and removal of weeds, brush and rubbish by the City of Grand Junction for the year 1930, are as follows, to-wit:
