Grand Junction, Colorado

November 19th, 1930

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were Councilmen Penberthy, Glassford, Bear, Hirons, Hall, Sievert, Rogers. City Manager Soderstrum, City Attorney Adams, and City Clerk Tomlinson were present.

The minutes of the regular meeting held November 5th were read and approved.

Petition for street light

A petition from residents in the vicinity of 11th & Pitkin Ave. was presented, asking that a light be installed on the corner of 11th & Pitkin. It was moved by Councilman Glassford and seconded by Councilman Hirons that the petition be referred to the City Manager. Motion carried.

Prop. Electrical ordinance

A proposed ordinance entitled "AN ORDINANCE REGULATING THE APPOINTMENT OF AN ELECTRICAL INSPECTOR AND REGULATING THE WIRING, EQUIPMENT, APPARATUS, FIXTURES, FITTINGS OR ANY OTHER ELECTRICAL DEVICES IN ANY BUILDING IN THE CITY OF GRAND JUNCTION", was brought up and read. It was moved by Councilman Penberthy and seconded by Councilman Hirons that the proposed ordinance be passed for publication. Motion carried.

A proposed ordinance entitled "AN ORDINANCE LEVYING A SPECIAL ASSESSMENT ON CERTAIN REAL ESTATE IN GRAND JUNCTION, FOR BENEFITS CONFERRED BY THE WATER WORKS OF SAID CITY", was introduced and read. It was moved by Councilman Hirons and seconded by Councilman Penberthy that the proposed ordinance be passed for publication. Motion carried.

An ordinance entitled "THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF GRAND JUNCTION, COLORADO, PROVIDING FOR THE EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION FOR THE FISCAL YEAR BEGINNING JANUARY 1st, A. D. 1931, AND ENDING DECEMBER 31st, A. D. 1931, AND DECLARING AN EMERGENCY, was introduced and read.

Ord. #477

It was moved by Councilman Glassford and seconded by Councilman Penberthy that the proposed ordinance be passed and adopted as an emergency ordinance, numbered 477, and published. Upon which motion the following vote was cast: Councilmen voting YEA, Penberthy, Glassford, Bear, Hirons, Hall, Sievert, Rogers. Councilmen voting No - None. All of the Councilmen voting YEA, the

President declared the motion carried, and the ordinance duly passed and adopted as an emergency, ordinance.

Tax sale certificate

A petition from Mr. J. S. Shaw for the tax certificates which the City holds against Lots 8, 9, 10, Block 17, in the sum of \$220.14, was presented. Mr. Shaw asked to be allowed to buy the tax certificates with interest at the rate of 6% instead of the regular rate of 1% per month and penalties.

It was moved by Councilman Glassford and seconded by Councilman Hirons that the request of Mr. Shaw be laid on the table until the next meeting, and that more complete information be secured concerning the general taxes and interest and penalties covering this property.

It was moved by Councilman Hirons and seconded by Councilman Bear that the meeting adjourn, to meet at the call of the President.
