

Grand Junction, Colorado

June 17th, 1931

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were: Councilmen Bear, Glassford, Hall, Hirons, Holcombe, Sievert. Councilman Roberts was absent. City Manager Soderstrum, City Attorney Adams and City Clerk Tomlinson were present.

The minutes of the regular meeting held June 3rd were read and approved.

The following notice was presented and read:

ELECTION NOTICE

CITY OF GRAND JUNCTION, COLORADO
NOTICE OF SPECIAL MUNICIPAL ELECTION
TO BE HELD ON TUESDAY THE 30th DAY OF JUNE, 1931

PUBLIC NOTICE IS HEREBY GIVEN THAT a Special Municipal Election will be held Tuesday, the 30th day of June, A. D. 1931, at the polling places hereinafter designated in the City of Grand Junction, Colorado.

The said Special Municipal Election will be held at the several polling places in the several districts and voting precincts of the City of Grand Junction, in the State aforesaid as follows:

District A, City Voting Precinct 9, Polling Place, City Hall
District B, City Voting Precinct 10, Polling Place, Chamber of Commerce, 127 N. 4th St.
District C, City Voting Precinct 11, Polling Place, Y.M.C.A.
District D, City Voting Precinct 12, Polling Place, Mutual Motors Garage, 120 S. 7th St.
District E, City Voting Precinct 16, Polling Place, Christian Church.

Upon the date and at the places designated aforesaid, the polls will be open from the hour of 7 o'clock, A. M. to and including and will be closed at the hour of 7 o'clock P. M. The ballots to be used in voting upon the question submitted will be prepared and furnished by the City Clerk to the Judges of the election, to be by them furnished to the voters. The election will be held and conducted as nearly as may be, in the manner prescribed by law in the case of elections for municipal officers. Registration for the said election will take place in the manner provided by law. At said election only duly qualified tax paying electors of the City shall be permitted to vote upon the questions submitted.

That at said election the following proposed ordinance will be submitted to the qualified tax paying electors of the City of Grand Junction, for their adoption or rejection.

An Ordinance Entitled: "AN ORDINANCE GRANTING TO PUBLIC SERVICE COMPANY OF COLORADO, ITS SUCCESSORS AND ASSIGNS, THE RIGHT TO LOCATE, BUILD, CONSTRUCT, MAINTAIN AND OPERATE INTO, WITHIN AND THROUGH THE CITY OF GRAND JUNCTION, A PLANT OR PLANTS AND WORKS FOR THE GENERATION, TRANSMISSION AND DISTRIBUTION OF ELECTRICITY AND TO FURNISH, SELL, DISTRIBUTE SAID PRODUCTS TO THE CITY AND THE INHABITANTS THEREOF, BY MEANS OF CONDUITS, CABLES, POLES AND WIRES STRUNG THEREON OR OTHERWISE, OVER, UNDER, ALONG AND ACROSS ALL STREETS, ALLEYS, BRIDGES, PUBLIC WAYS AND PLACES IN SAID CITY AND FIXING THE TERMS AND CONDITIONS THEREOF, AND PROVIDING FOR RATES AND STANDARDS OF SERVICE."

IN WITNESS WHEREOF, The City Council of the City of Grand Junction, has caused this notice to be published and posted as required by law, and dated this 7th day of June, A. D. 1931.

Shelly granted Plumber's License

A letter from Mr. Burroughs, Plumbing Inspector was read, in which he stated that Mr. Fred Shelly had successfully passed an examination for Master Plumber, and recommended that he be granted a Master Plumber's license. Councilman Holcombe moved and Councilman Hirons seconded the motion that Mr. Shelly be granted a Master Plumber's license. Motion carried.

1931 Band Concerts

Messrs. O. L. Roberts and Milo Brown were present and discussed the matter of band concerts this Summer. It was agreed to give the High School band an opportunity to play this Summer, and it was recommended that Mr. Soderstrum come to definite understanding with the High School Band, and then discuss the matter with Mr. Roberts.

Driveway on 4th & Rood

A petition from Mr. W. W. Reynolds and also Mr. Harrison J. Teller, President of The Argonaut Hotel Association, requesting that they be allowed to put in a twenty-five foot driveway on Rood Avenue and a twenty-five foot gravel driveway on N. 4th Street, for the convenience of the root beer stand being erected on the corner of 4th & Rood Avenue.

It was moved by Councilman Hall and seconded by Councilman Holcombe that the City Manager be authorized, at his discretion, to permit a driveway not to exceed twenty-five feet in width, to be constructed at the Southwest corner of Lots 17 to 20 inc., Block 97, and that he be further authorized to permit a temporary gravel driveway to be constructed on the North Fourth Street side of the lots. Motion carried.

The following motion was made by Councilman Sievert and seconded by Councilman Hall:

Deed to land to M.S. Patterson

It appearing to the Council that a deed has been prepared in proper form by the City Attorney, from the City of Grand Junction to M. S. Patterson, conveying to him land belonging to the City and described in People's Ordinance No. 23, to be exchanged for land belonging to said M. S. Patterson, and that the City

Attorney has examined the abstract to the land belonging to said Patterson, and same has been found satisfactory, therefore the President of the Council and the City Clerk are hereby authorized and directed to execute said deed on behalf of the City.

Roll was called with the following result:

Councilmen voting NAY - None.

All of the Councilmen present voting AYE, the President declared the motion carried.

It was moved by Councilman Holcombe and seconded by Councilman Bear that the meeting adjourn.
