July 1st, 1931

The City Council of the City of Grand Junction, Colorado, met in regular session at 6:30 o'clock P. M. Those present and answering at roll call were: Councilmen Bear, Glassford, Hall, Hirons, Holcombe, Roberts, Sievert. President Glassford presided. City Attorney Adams, City Manager Soderstrum, and City Clerk Tomlinson were present.

The minutes of June 17th were read and approved.

Unfred Bond

The bond of George L. Unfred, Plumber, having been approved as to form by the City Attorney, was presented. It was moved by Councilman Hall and seconded by Councilman Holcombe that the bond be accepted and filed. Motion carried.

Pav. Ouray 3-7

A petition for paving Ouray Avenue from Third Street to Seventh Street was presented. It was moved by Councilman Hirons and seconded by Councilman Holcombe that the petition be referred to the City Manager for checking, and filed in the office of the City Clerk, and that the City Manager be requested to secure prices on various types of pavement and report back to the Council. Motion carried.

Colo. Mun. League Conv.

It was moved by Councilman Bear and seconded by Councilman Roberts that the expenses of the City Manager and three Councilmen to the Colorado Municipal League Covention at Durango, be allowed. Motion carried.

Canvass votes

The City Council proceeded to canvass the votes of the Special Municipal election held June 30th, 1931.

The following is the report shown by the canvassing board:

TALLY SHEET

We, the undersigned, acting as canvassing board, hereby certify that we have canvassed the returns of the Special Municipal election held in the City of Grand Junction, Colorado, on June 30th, 1931, and from said canvass find the results to be as follows:

That 186 ballots were cast in District "A" That 210 ballots were cast in District "B" That 252 ballots were cast in District "C" That 246 ballots were cast in District "D" That 417 ballots were cast in District "E"

That a total of 1311 ballots were cast in all the Districts at said election.

The votes for the Ordinance granting the franchise were as follows:

"An Ordinance Granting to the Public Service Company of Colorado, its Successors and Assigns, the right to locate, build, construct, maintain and operate into, within and through the City of Grand Junction, a plant or plants and works for the generation, transmission and distribution of electricity and to furnish, sell and distribute said products to the City and the inhabitants thereof, by means of conduits, cables, poles, and wires strung thereon or otherwise, over, under, along and across all streets, alleys, bridges, public ways and places in said City and fixing the terms and conditions thereof, and providing for rates and standards of service."
