

Grand Junction, Colorado

August 5, 1931

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:00 o'clock P. M. Those present and answering at roll call were: Councilmen Hall, Hirons, Holcombe, Sievert, and President Glassford. Councilmen Bear and Roberts were absent. City Manager Soderstrum, City Attorney Adams, and City Clerk Tomlinson were present.

The minutes of the regular meeting held July 15th were read and approved.

Request to install flood lights at Western Slope Auto

A request from Winterburn Electric to install two flood lights at the Western Slope Auto Co., similar to those which had been installed at the Jones Bros. Service Station and the Goodrich Silvertown Station. All wiring to conform with the City electrical Ordinance.

It was moved by Councilman Hall and seconded by Councilman Holcombe that the request of Winterburn Electric on behalf of the Western Slope Auto Co. for flood lights be granted. Motion carried.

People's Ordinance No. 24

The Proof of Publication to the Proposed People's Ordinance entitled, "AN ORDINANCE GRANTING TO THE PUBLIC SERVICE COMPANY OF COLORADO, ITS SUCCESSORS AND ASSIGNS, THE RIGHT TO LOCATE, BUILD, CONSTRUCT, MAINTAIN AND OPERATE INTO, WITHIN AND THROUGH THE CITY OF GRAND JUNCTION, A PLANT OR PLANTS AND WORKS FOR THE GENERATION, TRANSMISSION AND DISTRIBUTION OF ELECTRICITY AND TO FURNISH, SELL AND DISTRIBUTE SAID PRODUCTS TO THE CITY AND THE INHABITANTS THEREOF, BY MEANS OF CONDUITS, CABLES, POLES AND WIRES STRUNG THEREON OR OTHERWISE, OVER, UNDER, ALONG AND ACROSS ALL STREETS, ALLEYS, BRIDGES, PUBLIC WAYS AND PLACES IN SAID CITY AND FIXING THE TERMS AND CONDITIONS THEREOF, AND PROVIDING FOR RATES AND STANDARDS OF SERVICE", was introduced and read by the Clerk. It was moved by Councilman Hirons and seconded by Councilman Sievert that the Proof of Publication be accepted and filed. Motion carried.

Said Proposed People's Ordinance No. 24, granting to the Public Service Company of Colorado said franchise was thereupon put upon its final passage, and the City Clerk then read said ordinance in full to the City Council.

It was moved by Councilman Hall and seconded by Councilman Hirons that the Proposed People's Ordinance No. 24, granting a franchise by the City of Grand Junction to the Public Service Company of Colorado, its successors and assigns, in accordance with the

terms therein stated, be now passed and adopted as People's Ordinance No. 24 of the City of Grand Junction. Motion carried.

It was moved by Councilman Holcombe and seconded by Councilman Hall that said Proposed People's Ordinance No. 24, granting a franchise by the City of Grand Junction to the Public Service Company of Colorado, its successors and assigns, be now passed and adopted as read as an ordinance of the City of Grand Junction.

The Ayes & Nays being called, Councilmen Hirons, Hall, Holcombe, Sievert, and Glassford voted Aye, and there were no Councilmen voted No. It appearing that all of the duly elected City Councilmen who were present voted AYE, and said People's Ordinance No. 24 was declared passed and adopted by the City of Grand Junction.

On motion of Councilman Hirons and seconded by Councilman Holcombe, the City Clerk was directed to publish said People's Ordinance No. 24 in the Daily Sentinel, a daily newspaper of general circulation, printed and published in said City of Grand Junction, and to obtain from the publisher thereof an affidavit of publication thereof and to make the same a part of the records of the City of Grand Junction. Roll was called with the following Councilmen voting AYE - Hall, Hirons, Holcombe, Sievert, Glassford. Councilmen voting NO - None. All of the Councilmen present voted AYE.

On motion of Councilman Holcombe seconded by Councilman Sievert, the City Clerk was directed to certify upon said People's Ordinance No. 24 the regular and proper certificate of its introduction, reading, first passage, second reading and final passage, and the facts concerning its publication in the Daily Sentinel as shown by the records of said City and the affidavits of publication on file, and to attest such facts on said ordinance. Roll was called with the following Councilmen voting AYE - Hall, Hirons, Holcombe, Sievert, Glassford. Councilmen voting NO - None. All of the Councilmen present voting AYE, the President declared the motion carried.

It was moved by Councilman Hall and seconded by Councilman Hirons that the meeting be continued until Thursday evening, August 6th, at 7:30 o'clock P. M.
