## Grand Junction, Colorado

November 18, 1931

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P.M. Those present and answering at roll call were: Councilmen Bear, Hall, Hirons, Holcombe, Roberts, Sievert, and President Glassford. City Attorney Adams, City Manager Soderstrum, and City Clerk Tomlinson were present.

The minutes of the regular meeting held November 4th and the regular adjourned session held November 6th were read and approved.

Propositions concerning Patterson lease on tract of land at Airport

City Attorney Adams reported that he had received a letter from Mr. Sternberg, Attorney for Henry Patterson, and submitted the following propositions:

1. That the City enter into a contract to buy the land at the option price of \$5,000.00; \$1,000.00 in one year, \$1,000.00 in two years, and \$3,000.00 in three years, or the last payment can be further extended; interest on deferred payments at the rate of 6% per annum.

2. A lease for three years at \$200.00 per annum, conditioned on the definite purchase of the property by the city on or before the expiration of such lease at the option price of \$5,000.00.

It was moved by Councilman Sievert and seconded by Councilman Hirons that the matter be referred to the Finance Committee and the City Attorney, to be reported back to the Council at a later meeting. Motion carried.

An Ordinance entitled, "AN EMERGENCY ORDINANCE PROVIDING AN APPROPRIATION FOR THE HIGHWAY DEPARTMENT", was introduced and read. It was moved by Councilman Roberts and seconded by Councilman Sievert that the ordinance as read be passed and adopted as an emergency ordinance, numbered 487, and published. Roll was called with the following result:

Councilmen voting AYE, Bear, Hall, Hirons, Holcombe, Roberts, Sievert, Glassford.

Councilmen voting NO - None.

All of the Councilmen voting AYE, the President declared the motion carried and the ordinance duly passed and adopted as an emergency.

Proposed Water Ordinance

A proposed ordinance entitled, "AN ORDINANCE LEVYING A SPECIAL ASSESSMENT ON CERTAIN REAL ESTATE IN GRAND JUNCTION, FOR BENEFITS CONFERRED BY THE WATER WORKS OF SAID CITY", was introduced and read.

It was moved by Councilman Hall and seconded by Councilman Bear that the proposed ordinance be passed for publication. Motion carried.

RESOLUTION

A RESOLUTION DETERMINING AND ASSESSING THE COST OF THE REMOVAL OF WEEDS, BRUSH AND RUBBISH, UNDER ORDINANCE NO. 236, AS AMENDED.

WHEREAS, Under Ordinance No. 236 of the City of Grand Junction, passed and adopted May 18, 1915, as amended by Ordinances No. 286 and 429, it is the duty of each and every person, corporation or association owning any lots, tracts or parcels of land within the City of Grand Junction, Colorado, to once each year cut to the ground all weeds and brush, and to remove the same, together with all rubbish of all kinds, from his, its or their said lots, tracts or parcels of land; and also to cut closely all weeds and brush and remove the same, together with all rubbish of all kinds, from the alleys abutting behind to the middle thereof and from the sidewalk areas, including the parking, abutting in front of said lots, tracts or parcels of land within said City; and that said duties shall be performed between the first day of July and the fifteenth day of July of each and every year; and

WHEREAS, Pursuant to said Ordinance, as so amended, the City Clerk of said City did, within the time provided therein, duly and regularly publish a notice notifying all owners of the property, without naming them, of their duty to cut the said weeds and brush and to remove same, together with their rubbish, from their property and from the streets and alleys, as in said Ordinance provided; and that in default thereof, the work would be done under orders of the City Manager, and the cost thereof, together with the penalties provided in said Ordinance, would be charged to the respective lots, tracts or parcels of land; and

WHEREAS, The hereinafter described owner or owners of certain tracts and parcels of land hereinafter described failed to cut and remove the weeds, brush and rubbish as therein provided, and within the time and in the manner provided by said notice, the said City Manager did thereupon proceed as soon as practicable thereafter to have such work done and to cut or cause to be cut and removed from such lots, alleys and sidewalk areas all of such weeds, brush and rubbish; and

WHEREAS, The City Manager of said City has made and filed with the said Council a report in writing, containing a clear statement of the work done by him or under his supervision, and the expenses incurred in so doing, showing the cost of such work and the cost for each lot or parcel of land, so that the Council may determine the cost of such work therefrom; and said report has been duly considered by said Council of the City of Grand Junction aforesaid.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION.

SECTION 1. That the Council finds and so determines that all matters and things prerequisite to the assessment of the cost of cutting weeds and removing brush for the year 1931 have been

fully done and performed in accordance with Ordinance No. 236 of said City, passed and adopted May 18, 1915, as amended.

SECTION 2. That, according to the report of the City Manager, it appears and the Council so determines the fact to be that the several amounts properly chargeable against the various delinquent owners and against each lot, parcel or other tract of land, on account of the cutting and removal of weeds, brush and rubbish by the City of Grand Junction for the year 1931, are as follows, to-wit:
