

Grand Junction, Colorado

January 20, 1932

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were: Councilmen Bear, Hall, Hirons, Holcombe, Roberts, Sievert, and President Glassford. City Manager Soderstrum, and City Clerk Tomlinson were present. City Attorney Adams was absent.

The minutes of the regular meeting held January 6th, 1932 were read and approved.

Application for Pawn Broker's license

L. Cook Sporting Goods Company made application for a Pawn Broker's License. It was moved by Councilman Hall and seconded by Councilman Bear that the matter be laid on the table until the next meeting of the Council. Motion carried.

Councilman Hall moved and Councilman Hirons seconded the motion that the City Manager be requested to remove watering troughs within the City, if they appear, after investigation, to be no longer needed. Motion carried.

All of the Councilmen voting AYE, the President declared the motion carried.
