

Grand Junction, Colorado

June 15, 1932

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were: Councilmen Bear, Hiron, Holcombe, Roberts, Sievert, and President Hall. Councilman Glassford was absent. City Manager Soderstrum, City Attorney Adams, and City Clerk Tomlinson were present.

The minutes of the regular session held June 1st were read and approved.

Fulton Pet. Accept franchise

The Fulton Petroleum Corp. presented their written acceptance to the franchise. Councilman Sievert moved and Councilman Bear seconded the motion that the Acceptance be filed and made of record with the People's Ordinance No. 25. Motion carried.

Ordinance concerning Medicine shows

An Ordinance entitled, "AN ORDINANCE TO REGULATE AND LICENSE ITINERANT VENDERS OF MEDICINES, DRUGS, AND NOSTRUMS", was introduced and read. It was moved by Councilman Holcombe and seconded by Councilman Hiron that the ordinance be passed for publication. Motion carried.

Resolution regarding funds

The following resolution was introduced and read:

RESOLUTION

WHEREAS, On October 7, 1931, the City Council passed a resolution directing that all moneys then in the fund of paving District No. 6 or which might thereafter accrue to said fund be transferred to the general fund of said city;

AND WHEREAS It appears that all outstanding bonds of said Paving District No. 6 and Sewer District No. 6 have been fully paid and discharged, and that, by reasons of the collection of delinquent taxes, payments are still being made into said Paving District No. 6;

AND WHEREAS It appears that an overdraft in the sum of \$634.84 exists in Sewer District No. 5, due to the anticipated payment of the remaining outstanding bonds of said district;

THEREFORE, BE IT RESOLVED That all moneys now in or which may hereafter accrue to the funds of said Sewer District No. 6 and Paving District No. 6 be transferred to the fund of Sewer District

No. 5 until the further order of the Council in the premises, and that the action of the Council on said October 7, 1931, in so far as it directs the payment into the general fund of moneys accruing to Paving District No. 6, be and it is hereby revoked and canceled; and that certified copies of this resolution be sent to the City Treasurer of Grand Junction, Colorado, for his authority herein.

It was moved by Councilman Sievert and seconded by Councilman Hirons that the resolution as read be passed and adopted. Roll was called on the motion with the following result:

Councilmen voting AYE - Bear, Hirons, Holcombe, Roberts, Sievert, and Hall.

Councilmen voting NO - None.

All of the Councilmen present voting AYE, the President declared the motion carried.

The City Manager presented considerable data on the Water Department, and the balance of the evening was spent in discussing matters pertaining to this Department.

Councilman Sievert moved and Councilman Hirons seconded the motion that the meeting adjourn.
