July 20, 1932

The City Council of the City of Grand Junction met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were Councilmen Bear, Glassford, Hirons, Holcombe, Roberts, Sievert, and President Hall. City Manager Soderstrum and City Attorney Adams were present. City Clerk Tomlinson was absent.

Mr. J. P. Soderstrum was designated as acting City Clerk pro-tem.

The minutes of the regular meeting held July 6th were read and approved.

Colo. Basket Co. water account stricken

Mr. Soderstrum explained that the Colorado Basket Company owed the City the sum of \$38.98 for water rent to the time of the closing of the business. This bill had been filed with the receiver for the company, and the City had been notified that there were no funds available for the payment of the account, and that there would be no funds available. It was recommended that the account be stricken from the books.

Councilman Sievert moved and Councilman Roberts seconded the motion that the account of the Colorado Basket Co. for water rent be canceled.

Roll was called upon the motion, with the following result: Councilmen voting AYE - Bear, Hirons, Glassford, Holcombe, Roberts, Sievert, and Hall.

No. - None.

All of the Councilmen voting AYE, the President declared the motion carried.

New Lead Service prices submitted

City Manager Soderstrum presented a new schedule of prices for the installation of lead services. Due to the reduction in the price of lead pipe and labor, a 10% reduction in the price of services was recommended. Councilman Hirons moved and Councilman Sievert seconded the motion that the recommendation of the City Manager be accepted and that a resolution be drawn up and published as required by law.

Roll was called with the following result: Councilmen voting AYE - Bear, Glassford, Hirons, Holcombe, Roberts, Sievert, and Hall.

Councilmen voting NO - None.

All of the Councilmen voting AYE, the President declared the motion carried.

A proposed ordinance entitled, "AN ORDINANCE AMENDING SECTION 8 OF ORDINANCE NO. 238, PASSED AND ADOPTED AUGUST 10, 1915 AS AMENDED BY ORDINANCE No. 347 PASSED AND ADOPTED JANUARY 30, 1924, AS AMENDED BY ORDINANCE NO. 397 PASSED AND ADOPTED DECEMBER 16, 1925, was introduced and read.

It was moved by Councilman Hirons and seconded by Councilman Glassford that the proposed ordinance be passed for publication. Motion carried.

The following report was filed by the Water Committee.
