

Grand Junction, Colorado

September 6, 1933

The City Council of the City of Grand Junction, Colo. met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were: Councilmen Carson, Ross, Oates, Boston, Hall, Roberts, and President Holcombe. City Manager Soderstrum, City Attorney Bowie, and City Clerk Tomlinson were present.

The minutes of the regular meeting held August 16th and the special meeting held August 25th were read and approved.

A petition signed by representatives of service clubs, Chamber of Commerce, Grand Junction Schools, Junior College, & Grand Junction Soft Ball League, requesting that the City authorize the lighting of the athletic field at Lincoln Park so that the field might be used for night football, softball, and other activities. Mr. Palrang, representing the Softball League presented the proposition to the Council, and explained that they had taken the matter up with the Public Service Co. and that they were willing to install the lighting equipment, and the City pay for the same out of the proceeds derived from the use of the field. Mr. C. G. Houston spoke to the Council, and told the history of other lighted fields, especially the softball field in Boulder, which was lighted a few years ago, and which has proved very satisfactory. Mr. Vorbeck, Mr. Colburn, R. Holt, Mr. Coe Van Deren, Mr. Harry Burnett, and others were also present in the interest of the matter.

It was moved by Councilman Hall and seconded by Councilman Roberts that the City Manager be instructed to negotiate with the Public Service Co. and such other organizations as in his opinion might well be made a party to the contract for lighting the football field and other fields in Lincoln Park, and that the President of the Council and the City Clerk be authorized to sign such contracts when formulated. (Motion carried.) Roll was called and all members of the Council voted AYE.

The following proposed emergency ordinance was introduced and read: "AN ORDINANCE RELATING TO THE LICENSING OF ITINERANT DENTISTS AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF". It was moved by Councilman Hall and seconded by Councilman Oates that the foregoing entitled ordinance be passed and adopted as an emergency ordinance, numbered 503 and published. Roll was called on the motion with the following result: Councilmen voting AYE - Carson, Ross, Oates, Boston, Hall, Roberts and Holcombe. All members of the Council voting AYE, the President declared the motion carried.

An ordinance concerning the sale of fruits and vegetables in the city of Grand Junction was introduced and read, and deferred until the next meeting.

A letter from County Treasurer W. S. Meek, requesting the Tax

Certificate No. 39818 for water main tax against lots 6 to 11 in Block 163, be canceled. The 1931 taxes were paid and not credited.

It was moved by Councilman Hall and seconded by Councilman Carson that Tax Certificate No. 39818, for 1931 water main tax against Lots 6 to 11, Block 163, be canceled. All Councilmen voted AYE, on roll call. Motion carried.

City Manager Soderstrum reported that the application for a loan and grant has been filed in Mr. George Bull's office, and Mr. John E. Field, Examining Engineer was on the ground looking over the site of the reservoir project to make his report. Action on the application is expected within a week.

There being no further business to come before the meeting, it was regularly moved and carried that the meeting adjourn.
