

Grand Junction, Colorado

December 20, 1933

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Those present and answering at roll call were Councilmen Carson, Ross, Oates, Boston, Roberts, Hall, and President Holcombe. City Manager Soderstrum, City Attorney Bowie, and City Clerk Tomlinson were present.

The minutes of the regular meeting held December 6th were read and approved.

An ordinance entitled, "AN ORDINANCE APPROPRIATING CERTAIN SUMS OF MONEY TO DEFRAY THE NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION, COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1st, 1934, AND ENDING DECEMBER 31st, 1934, AND DECLARING AN EMERGENCY, was introduced and read. It was moved by Councilman Hall and seconded by Councilman Ross that the emergency ordinance entitled, "AN ORDINANCE APPROPRIATING CERTAIN SUMS OF MONEY TO DEFRAY THE NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION, COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1st, 1934, AND ENDING DECEMBER 31st, 1934, BE PASSED and adopted as an emergency ordinance, numbered 508 and published. Roll was called on the motion with the following results: Councilmen voting AYE, Carson, Ross, Oates, Boston, Roberts, Hall, and Holcombe. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.

An ordinance entitled, "AN ORDINANCE TO LICENCE AND REGULATE THE DELIVERY AND SALE OF ICE, AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF", was introduced and read. It was moved by Councilman Ross, and seconded by Councilman Carson that the ordinance be passed and adopted as an emergency ordinance, numbered 509, and published. Roll was called on the motion with the following results: Councilmen voting AYE, Carson, Ross, Oates, Boston, Roberts, Hall, and Holcombe. Councilmen voting NO, None. All of the Councilmen voting AYE, the President declared the motion carried.

An ordinance entitled, "AN ORDINANCE AMENDING ORDINANCE NO. 238, AS AMENDED BY ORDINANCE NO. 397, was introduced and read. It was moved by Councilman Roberts and seconded by Councilman Oates that the ordinance be passed and adopted as an emergency ordinance, numbered 510, and published. Roll was called on the motion with the following results: Councilmen voting AYE, Carson, Ross, Oates, Boston, Roberts, Hall, and Holcombe. Councilmen voting NO, None. All of the Councilmen voting AYE, the President declared the motion carried.

An ordinance entitled, "AN ORDINANCE RELATING TO THE LICENSING OF PEDDLERS AND SOLICITORS AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF", was introduced and read. It was moved by

Councilman Roberts and seconded by Councilman Hall that the ordinance be passed and adopted, as an emergency ordinance numbered 511, and published. Roll was called on the motion with the following results: Councilmen voting AYE, Carson, Ross, Oates, Boston, Roberts, Hall, and Holcombe. Councilmen voting NO, None. All of the Councilmen voting AYE, the President declared the motion carried.

An ordinance entitled, "AN ORDINANCE RELATING TO THE LICENSING OF TRANSIENT MERCHANTS AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF," was introduced and read. It was moved by Councilman Carson and seconded by Councilman Roberts that the ordinance be passed and adopted as an emergency ordinance, numbered 512, and published. Roll was called on the motion with the following results: Councilmen voting AYE, Carson, Ross, Oates, Boston, Roberts, Hall, and Holcombe. Councilmen voting NO- None. All of the Councilmen voting AYE, the President declared the motion carried.

An ordinance entitled, "AN ORDINANCE AMENDING ORDINANCE NO. 280 AS AMENDED BY ORDINANCE NO. 315, was introduced and read. It was moved by Councilman Ross and seconded by Councilman Roberts that the ordinance be passed and adopted as an emergency ordinance, numbered 513, and published. Roll was called on the motion with the following results: Councilmen voting AYE, Carson, Ross, Oates, Boston, Roberts, Hall, and Holcombe. Councilmen voting NO, None. All of the Councilmen voting AYE, the President declared the motion carried.

Several other ordinances were introduced, and considered. Several were referred to the City Attorney for changes.

It was moved by Councilman Ross and seconded by Councilman Roberts that the meeting adjourn until Wednesday evening, December 27th, 1933, at 7:30 o'clock.
