## Grand Junction, Colorado

March 5th, 1934

The City Council of the City of Grand Junction, Colo. met in regular adjourned session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Ross, Oates, Boston, Hall, and President Holcombe. Councilman Roberts was absent. City Attorney Bowie and City Clerk Tomlinson were present. City Manager Soderstrum was absent.

It was moved by Councilman Carson and seconded by Councilman Boston that the City call in all the skrip that is still outstanding, on a basis of 80%, that is, if the skrip is stamped 80% to redeem it at 100%. Roll was called on the motion, with the following result:

Councilmen voting AYE, Carson and Boston.

Councilmen voting NO - Ross, Oates, Hall, and Holcombe.

A majority of the Councilmen present voting NO, the President declared the motion lost.

The matter of the proposed ordinance pertaining to the licensing of coal dealers and truckers was brought up. Mr. Hinman, representing the coal dealers, and Messrs. Goodrich, Colescott, Jaros, and Luther; Mr. Heckman, Mr. John Fonder, Mr. Geo. Tilton, Mr. Wm. McGinley, and Mr. Zimmerman, who represented the truckers side of the question were all present and spoke concerning the ordinance.

After considerable discussion it was moved by Councilman Hall and seconded by Councilman Ross that the proposed ordinance entitled, "AN ORDINANCE REGULATING THE BUSINESS OF SELLING AND/OR DELIVERING COAL, COKE, AND CHARCOAL WITHIN THE CITY OF GRAND JUNCTION: REGULATING THE TIME AND METHOD OF DELIVERY AND THE WEIGHING THEREOF: DEFINING GRADES OF COAL: PROVIDING FOR A LICENSE FOR THOSE ENGAGED IN THE BUSINESS OF SELLING AND DELIVERING COAL, COKE AND CHARCOAL WITHIN THE CITY OF GRAND JUNCTION, AND FOR AN OCCUPATION TAX TO BE PAID FOR SUCH LICENSE, AND PROVIDING EXEMPTION FROM THE PROVISIONS HEREOF, AND PENALTIES FOR THE VIOLATIONS HEREOF", be passed for publication.

Roll was called on the motion with the following result:

Councilmen voting AYE - Ross, Oates, Hall, and Holcombe.

Councilmen voting NO - Carson and Boston.

A majority of the Councilmen voting AYE, the President declared the motion carried, and the ordinance passed for publication.

Councilman Carson moved and Councilman Hall seconded the motion that the meeting adjourn.
