April 18, 1934

The City Council of the City of Grand Junction met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Carson, Ross, Oates, Boston, Hall, and President Holcombe. Councilman Roberts was absent. City Manager Soderstrum, City Attorney Bowie, and City Clerk Tomlinson were present.

The minutes of the regular meeting held April 4th were read and approved.

At this time the City Council proceeded to open bids for the construction of the settling basin and reservoir. Mr. Frank Kellar, representative from the State Engineer's office (P. W. A.) in Denver was also present.

Three bids were submitted, those of W. O. Allison, A. S. Horner, and Page-Claybaugh Engineering Corp, as follows:

The members of the Council adjourned to the City Manager's office to discuss the bids informally.

After due time, the Council again met in regular session in the City Council room.

Councilman Ross moved that the bid of the Page-Claybaugh Engineering Corp. be rejected on account if its being incomplete, informal, and has other inaccuracies, and that the bid bond be returned to the company, together with the Statement of Competency. Councilman Carson seconded the motion.

Roll was called on the motion, with the following result:

Councilmen voting AYE - Carson, Ross, Oates, Boston, Hall, and Holcombe.

Councilmen voting NO - None.

All of the Councilmen voting AYE, the President declared the motion carried.

Councilman Carson moved that the bid of A. S. Horner be accepted, as the lowest responsible bidder, and that the contract under consideration be awarded to him, subject to the approval of the State Engineer P. W. A. Councilman Boston seconded the motion.

Roll was called on the motion with the following result:

Councilmen voting AYE - Carson, Ross, Oates, Boston, Hall, and Holcombe.

Councilmen voting NO - None.

All of the Councilmen voting AYE, the President declared the motion carried.

Applications for renewal of licenses to sell 3.2 beer and wine were made by Western Cafe, St. Regis Hotel, and City Market.

Councilman Carson moved and Councilman Boston seconded the motion that licenses be granted to the above mentioned places for the sale of beer and wine during the ensuing year. Motion carried.

Mr. N. W. Bryant made application to sell 3.2 beer and wine at his restaurant at 529 Main

St. It was moved by Councilman Hall and seconded by Councilman Oates that a 3.2 beer and wine license be granted to N. W. Bryant. Motion carried.

The Elks Club made application for a license to sell liquor at their Club rooms. Councilman Carson moved that the license be granted. Councilman Hall seconded the motion. Roll was called on the motion with the following result:

Councilmen voting AYE - Carson, Oates, Boston, Hall, Holcombe

Councilmen voting NO - Ross.

A majority of the Councilmen voting AYE, the President declared the motion carried.

Councilman Carson reported that he and the City Manager had gone to Denver and interviewed Governor Johnson in behalf of Mr. Weiser being reappointed to the State Highway Advisory Board, and that in his opinion, the Governor would seriously consider Mr. Weiser's reappointment.

Mr. Soderstrum stated that while in Denver, he had called on Mr. Vail, State Highway Engineer in regard to the footbridge on the Fifth Street Bridge. Mr. Vail stated that they might use 3% gasoline money to finish up the necessary amount required to build the footbridge.

Councilman Carson moved and Councilman Hall seconded the motion that the meeting adjourn until Thursday evening at 7:30 o'clock P. M.
