#### Grand Junction, Colorado

### March 20, 1935

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were - Carson, Ross, Oates, Boston, Roberts, Hall, and President Holcombe. City Attorney Bowie, City Manager Soderstrum, and City Clerk Tomlinson were present.

The minutes of the regular meeting held March 6th were read and approved.

Mr. Borschell appeared before the Council and made an offer of face value, \$295.49 for Tax sale certificates Nos. 36829 to 33, 37052 to 56, 37270 to 74, on Lots 12 to 16 Inc. Block 36, property being located on the corner of 4th & Hill.

It was moved by Councilman Carson and seconded by Councilman Roberts that the City Treasurer be authorized to sell and assign Treasurer's certificates of purchase Nos. 36829-33, 37052-56, 37270-74, for the amount of \$295.49 principal, at any time within 30 days from and after this date, provided that the purchaser and assignee thereof shall also pay or settle the general taxes on the property in question, within such period.

Roll was called on the motion with the following result: Councilmen voting AYE - Carson, Ross, Oates, Boston, Hall, and Holcombe, and Roberts, Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.

The Proof of Publication to the Ordinance entitled, "AN ORDINANCE TO AMEND THE ZONING MAP ACCOMPANYING ORDINANCE NO. 432, AND BEING A PART THEREOF", was introduced and read by the Clerk. It was moved by Councilman Oates and seconded by Councilman Ross that the Proof of Publication be accepted and filed. Motion carried.

It was then moved by Councilman Roberts and seconded by Councilman Ross that the ordinance be called up for final passage. Motion carried.

Councilman Carson moved and Councilman Roberts seconded the motion that the ordinance entitled, "AN ORDINANCE TO AMEND THE ZONING MAP ACCOMPANYING ORDINANCE NO. 432, AND BEING A PART THEREOF, be passed and adopted, numbered 532, and published. Roll was called on the motion with the following result: Councilmen voting AYE, Carson, Ross, Oates, Boston, Roberts, Hall, and Holcombe. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.

A petition signed by various hotel owners within the City was presented, requesting that the ordinance restricting all night parking be repealed. This matter was laid over until the next meeting of the Council.

The Veterans of Foreign Wars have been promoting a Walkathon which is being held in the Margery Building. Several members of the V.F.W. one of the Managers of the Walkathon, delegations from the Rotary Club, Lions Club, and Chamber of Commerce appeared before the Council. The Chamber of Commerce filed a letter of protest to the Walkathon, and requested that the Council take steps at once to close the contest. The Lions Club also protested the continuance of the contest, as did Mr. R. S. Harvey, Manager of the Mileaway dance hall and the Green Lantern Club. Mr. Decker, Manager of the Mesa Theater also spoke to the Council against the Walkathon. Mr. Henry Tupper, Atty. was the speaker representing the Lions and Chamber of Commerce.

The Council had before them an ordinance regulating this manner of contest, and after considerable discussion, the proposed emergency ordinance entitled, "AN ORDINANCE PROHIBITING EXHIBITION OR CONTESTS OF HUMAN PHYSICAL ENDURANCE IN DANCING, RACING OR WALKING, OR OF SIMILAR NATURE, WITHIN THE CITY OF GRAND JUNCTION FOR MORE THAN ONE WEEK AND PROVING PENALTIES FOR ENFORCEMENT THEREOF", was introduced and read by the Clerk.

It was moved by Councilman Ross and seconded by Councilman Oates that the ordinance be passed as an emergency, numbered 533, and published. Roll was called on the motion, with the following result: Councilmen voting AYE, Carson, Ross, Oates, Boston, Roberts, Hall, and Holcombe. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.

The following resolution was presented:

It is hereby resolved by the City Council of the City of Grand Junction that its City Manager be and is hereby directed to maintain at the Walkathon exhibition now being conducted at the Margery Hall in this City, during all times when large crowds are there assembled, one uniformed member of the Fire Department and one uniformed member of the Police Department, and to require the utmost vigilence of such departments to avoid any possible injury to the public attending such exhibitions; that the City Manager is further directed to require of the management of such exhibition, as a safeguard against possible injury to the public, that it eliminate the present over-crowded condition at such exhibition by materially reducing the present seating capacity and restrict admittance thereto, and by keeping all exits from such hall clear of loiterers and all obstructions.

It was moved by Councilman Hall and seconded by Councilman Carson that the resolution be passed and adopted as read. Roll was called on the motion with the following result: Councilmen voting AYE, Carson, Ross, Oates, Boston, Roberts, Hall, and Holcombe. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.
