The City Council of the City of Grand Junction, Colorado, met in regular adjourned session at 10:30 o'clock A. M. Councilmen present and answering at roll call were Councilmen Carson, Ross, Oates, Boston, Roberts, Hall, and President Holcombe. City Manager Soderstrum, City Attorney Bowie, and City Clerk Tomlinson were present.

The minutes of the regular meeting held on May 1st, 1935 were read and approved.

The Council discussed some questions regarding the sale of tax sale certificates, especially that general tax certificates be not sold unless the special assessment certificates are taken care of.

The following resolution was presented by Councilman Ross. Councilman Roberts seconded the motion.

The newly elected and hold-over members of the City Council of the City of Grand Junction, Colorado, met in their first regular meeting at 10:00 o'clock A. M. Members present were Carson, Ross, Oates, Boston, Roberts, Holcombe, and Enstrom. City Manager Soderstrum,

City Attorney Bowie, and City Clerk Tomlinson.

The three newly elected Councilmen, Holcombe, Roberts, and Enstrom were sworn in by Helen C. Tomlinson, Notary Public.

It was moved by Councilman Holcombe and seconded by Councilman Oates that Councilman Carson be elected as temporary chairman. Motion carried.

Councilman Carson thereupon took the Chair and presided during the balance of the meeting.

Councilman Roberts moved and Councilman Holcombe seconded the motion that Councilman Carson be elected as President of the Council and Ex-Officio Mayor of the City of Grand Junction. Roll was called on the motion with the following result: Councilmen voting AYE- Holcombe, Ross, Oates, Boston, Roberts, and Enstrom. Councilmen voting No - None. All of the Councilmen voting AYE, the President declared the motion carried.

It was moved by Councilman Holcombe and seconded by Councilman Boston that the meeting adjourn until Wednesday, May 8th at 7:30 o'clock P.M.
