

Grand Junction, Colorado

October 16, 1935

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were: Ross, Holcombe, Oates, Boston, Roberts, Enstrom, and Carson. City Manager Soderstrum, City Attorney Bowie, and City Clerk Tomlinson were present.

The minutes of the regular meeting held October 2nd were read and approved.

A delegation consisting of Messrs. Helman, Willsea, Tupper, Bradfield, and Jas. Milne appeared before the Council and requested the Council to take further steps to request the State Highway Department to build an underpass rather than an overpass at the South Fifth Street Railway Crossing. A letter from Chas. Vail was read, in which it was stated that it had been decided that an overpass would be constructed. Mr. Soderstrum spoke of several engineering matters in connection with this construction. All members expressed themselves as preferring a pass, but stated that they would not care to take any steps that would cause the Department to defer the construction of some crossing elimination at this point. It was suggested that a committee go to Denver and speak to Mr. Vail and Governor Johnson about this matter.

Mr. Severson appeared before the Council in connection with the driveways for the filling station at Fifth and North Avenue. Mr. Soderstrum reported that he had gone into the matter with Mr. Severson and would recommend that one twenty-five foot driveway be constructed on Fifth Street and two twenty-five foot driveways on North Ave.

It was moved by Councilman Oates and seconded by Councilman Holcombe that Mr. Severson be granted one twenty-five foot driveway on Fifth Street and two twenty-five foot driveways on North Avenue according to Mr. Soderstrum's recommendations. Motion carried.

An application for a restaurant liquor license for Jack Dupree, who plans on opening a restaurant at 332 Main Street was presented. It was moved by Councilman Holcombe and seconded by Councilman Enstrom that a license be granted to Mr. Jack Dupree for the sum of \$80.00 until December 31st, 1935, subject to the issuance of a license by the State of Colorado. Roll was called on the motion with the following result: Councilmen voting AYE - Ross, Holcombe, Oates, Boston, Enstrom, and Carson. Councilmen voting NO - Roberts. A majority of the Councilmen voting AYE, the President declared the motion carried.

A request from Mr. McCormick to be allowed to install loud speakers on the Marquee at Montgomery Ward & Co. during the radio show, October 17, 18, and 19 was made.

It was moved by Councilman Holcombe and seconded by Councilman Enstrom that the request be granted subject to restrictions as to volume, hours, etc. as the City Manager may recommend. Roll was called on the motion with the following result: Councilmen voting AYE

- Holcombe, Oates, Boston, Roberts, Enstrom, and Carson. Councilmen voting NO - Ross. A majority of the Councilmen voting AYE, the President declared the motion carried.

There was some discussion of traffic signals for various intersections, but no definite action taken.

It was moved by Councilman Oates and seconded by Councilman Enstrom that the meeting adjourn. Motion carried.
