

Grand Junction, Colorado

December 18, 1935

The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P. M. Councilmen present and answering at roll call were Ross, Holcombe, Oates, Boston, Roberts, Enstrom, and Carson. City Manager Soderstrum, City Attorney Bowie, and City Clerk Tomlinson were present.

The minutes of the regular meeting held December 4th and the special meetings held December 9th and 12th were read and approved.

The following entitled emergency ordinance was presented, "AN ORDINANCE PROVIDING FOR AN EMERGENCY APPROPRIATION FOR VARIOUS DEPARTMENTS OF THE CITY OF GRAND JUNCTION", It was moved by Councilman Holcombe and seconded by Councilman Enstrom that the emergency ordinance entitled, "AN ORDINANCE PROVIDING FOR AN EMERGENCY APPROPRIATION FOR VARIOUS DEPARTMENTS OF THE CITY OF GRAND JUNCTION", be passed and adopted, numbered 538, and published in the Daily Sentinel, in its issue of December 19th, 1935. Roll was called on the motion with the following result: Councilmen voting AYE - Ross, Oates, Holcombe, Boston, Roberts, Enstrom, and Carson. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried, and the ordinance duly passed and adopted.

The Proof of Publication to the Ordinance entitled, "AN ORDINANCE CONCERNING SALARIES", was presented. It was moved by Councilman Oates and seconded by Councilman Holcombe that the Proof of Publication be accepted and filed. Motion carried.

It was moved by Councilman Ross and seconded by Councilman Boston that the ordinance be called up for final passage. Motion carried.

It was then moved by Councilman Enstrom and seconded by Councilman Roberts that the ordinance entitled, "AN ORDINANCE CONCERNING SALARIES", be passed and adopted, numbered 539, and published. Roll was called on the motion with the following result: Councilmen voting AYE - Ross, Holcombe, Oates, Boston, Roberts, Enstrom, and Carson. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.

Applications for the position of City Treasurer were read; as follows:

Fred Peck, H. V. Zimmerman, and Francis I. Stringer.

After some discussion it was decided to ballot on the three applications. The first ballot showed the following result::

It was moved by Councilman Holcombe and seconded by Councilman Roberts that Francis Stringer be appointed to the position of City Treasurer, to take office as soon as his bond has been approved by the City Attorney and filed in the office of the City Clerk. Roll was called on the motion with the following result: Councilmen voting AYE - Ross, Holcombe, Oates, Boston, Roberts, Enstrom, and Carson. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.

Mr. R. F. Houtz presented an offer to purchase tax sale certificates on Lot 28, Block 106 for face value. It was moved by Councilman Holcombe and seconded by Councilman Enstrom that the City Treasurer be authorized to sell and assign Special Assessment Tax Sale Certificates numbered 36872 - 37089 - 37194 - 37195 for face value, at any time within thirty days from and after this date; providing that the purchaser and assignee thereof also pay or settle the general taxes on the property in question, within such period. This property is known as Lot 28, Block 106, Grand Junction. Roll was called on the motion and all Councilmen voted AYE on the motion.

Applications for 18-foot driveways at 1302 and 1260 Main were read. It was moved by Councilman Enstrom and seconded by Councilman Ross that the requests for 18-foot driveways be granted. Motion carried.

The matter of group insurance, as submitted by Roy Chapman at a previous meeting was brought up and discussed. It was moved by Councilman Roberts and seconded by Councilman Boston that the group insurance plan be rejected. Motion carried.

It was moved by Councilman Ross and seconded by Councilman Roberts that the meeting adjourn. Motion carried.
