## Grand Junction, Colorado

## December 9, 1936

The City Council of the City of Grand Junction met in special session at 7:30 o'clock P.M. Councilmen present and answering at roll call were: Holcombe, Groves, Boston, Carson, Enstrom, and President Oates. Councilman Ross was absent. City Manager Soderstrum, and City Clerk Tomlinson were present. City Attorney Bowie was absent.

It was moved by Councilman Groves and seconded by Councilman Carson that, owing to the necessity for calling a meeting of the Council on short notice, and each member having been duly notified, that the provision set forth in Ordinance No. 502 providing that notice be served upon the individual Councilman be waived, and that the said call is hereby ratified. Roll was called on the motion with the following result: Councilmen voting AYE - Holcombe, Groves, Boston, Carson, Enstrom, and Oates. Councilmen voting NO - None. All of the Councilmen present voting AYE, the President declared the motion carried.

It was moved by Councilman Groves and seconded by Councilman Carson that the budget for the year 1937, as presented by City Manager Soderstrum be accepted. Motion carried.

Councilman Ross being ill, and unable to come to the Council Chamber, it was moved by Councilman Carson and seconded by Councilman Boston that the Council adjourn to Mr. Ross' home at 844 Grand Avenue to consider the annual appropriation ordinance. Motion carried.

The City Council met at the home of Mr. Ross and was called to order by President Oates. All members were present.

It was moved by Councilman Groves and seconded by Councilman Ross that the emergency ordinance entitled, "AN ORDINANCE APPROPRIATING CERTAIN SUMS OF MONEY TO DEFRAY THE NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION, COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1ST, 1937, AND ENDING DECEMBER 31st, 1937, AND DECLARING AN EMERGENCY", be passed and adopted, numbered 559, and published. Roll was called on the motion with the following result: Councilmen voting AYE - Ross, Holcombe, Groves, Boston, Carson, Enstrom and Oates. Councilmen voting No - None. All of the Councilmen voting AYE, the President declared the motion carried, and the ordinance duly passed and adopted.

The following resolution was presented and read;

## RESOLUTION

A RESOLUTION AUTHORIZING THE CITY OF GRAND JUNCTION TO FILE AN APPLICATION TO THE UNITED STATES OF AMERICA THROUGH THE FEDERAL

EMERGENCY ADMINISTRATION OF PUBLIC WORKS FOR A GRANT TO AID IN FINANCING THE CONSTRUCTION OF A PUBLIC LIBRARY AND DESIGNATING J.P. SODERSTRUM & ROBERT K. FULLER TO FURNISH SUCH INFORMATION AS THE GOVERNMENT MAY REQUEST.

BE IT RESOLVED By the City Council of the City of Grand Junction:

Section 1. That J. P. Soderstrum, be and he is authorized to execute and file an application on behalf of the City of Grand Junction to the United States of America for a grant to aid in financing the construction of a Public Library.

Section 2. That J. P. Soderstrum and Robert K. Fuller be hereby authorized and directed to furnish such information as the United States of America through the Federal Emergency Administration of Public Works may reasonably request in connection with the application which is herein authorized to be filed.

It was moved by Councilman Enstrom and seconded by Councilman Carson that the Resolution be passed and adopted as read. Roll was called on the motion with the following result: Councilmen voting AYE - Ross, Holcombe, Groves, Boston, Enstrom, Carson, and Oates. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.

The Council thereupon adjourned back to the Council Chamber at the City Hall, and conducted the balance of the meeting at that place.

Ella Harrison and Anna Chellew presented an application for the renewal of a 3.2 beer license for Big Boy's Cafe. It was moved by Councilman Enstrom and seconded by Councilman Groves that the license be granted. Motion carried.

It was moved by Councilman Boston and seconded by Councilman Carson that the meeting adjourn. Motion carried.
