It was moved by Councilman Holcombe and seconded by Councilman Groves that the proposed ordinance be passed for publication. Motion carried.

water mains on Elm Ave.

Mr. Soderstrum stated that Mr. Gormley consulted with him relative to installing water mains on Elm Avenue, and had agreed that he will personally see to it that a north and south street is given through the tract recently opened to the public. The Council were of the opinion that no water mains should be installed until it has been definitely agreed by the owners of the property, that a north and south street will be provided through this property.

It was moved by Councilman Carson and seconded by Councilman Groves that the City Manager be authorized to purchase the necessary pipe for Elm Avenue, but not to lay same until the

matter of the streets in this tract has been settled satisfactorily. Roll was called on the motion and all members of the Council voted AYE. The President pro-tem declared the motion carried.

hearing on L.C. Anderson liquor license

A hearing had been called for this date, to allow interested parties to state their opinions on the application of L. C. Anderson for a license to sell liquor in a building to be erected at 626 Main St. Mr. Anderson was not present, and it was reported that Mr. Warren, the owner of the building had made no arrangements for a building to be constructed at this location, and had no intentions of constructing a building for this purpose. Two petitions were filed protesting against this license being issued - one from the business people in the block and the other from the Presbyterian Ladies Aid Society.

It was moved by Councilman Boston and seconded by Councilman Carson that the license be not granted to Mr. Anderson. Motion carried.

driveway 860 First Ave

A petition was filed requesting a driveway fourteen feet in width at 860 First Ave. It was moved by Councilman Carson and seconded by Councilman Oates that the request be granted. Motion carried.

O.M. Brown tax offer

Mr. O. M. Brown offered \$35.00 for the generals and specials against Lots 17 to 30, Block 9, Milldale. Face value of these certificates is \$139.12 generals and \$11.19 specials. It was moved by Councilman Holcombe and seconded by Councilman Boston that the request be denied. Motion carried.

Poland app. for beer lic.

H. A. Poland filed an application for a 3.2 beer license for the Silver Moon Cafe. It was moved by Councilman Holcombe and seconded by Councilman Carson that the request be granted and a license issued to Mr. Poland when his state license has been received. Motion carried.

Purity Grocery app. for beer lic.

Frank H. Marquis and Nelson L. McBee made an application for a 3.2 beer license for the Purity Grocery at 524 North First Street. It was moved by Councilman Groves and seconded by Councilman Boston that the license be issued when the State license has been received. Motion carried.

beer licenses renewed

Applications for renewals of 3.2 beer licenses for East Side Grocery, LaCourt Hotel, Grand Cafe, Bryant's Cafe, and O & P Cafe were filed. It was moved by Councilman Holcombe and seconded by Councilman Groves that the licenses be renewed. Motion carried.

Sometime ago the County purchased the special tax sale certificates against Lots 1, 2, and 3, Block 94 for \$1,054.20. This action was brought up for ratification.

It was moved by Councilman Carson and seconded by Councilman Boston that the City Treasurer be instructed to sell and assign Special Assessment Tax Sale Certificates Nos. 30790-1-2; 30884-5-6; 31040-1-2; 31092-3-4; 31189-90-01; for the sum of \$1,054.20, at any time within thirty days from and after this date, providing the purchaser and assignee thereof pay or settle the general taxes on the property in question within such period. Roll was called on the motion with all members of the Council present voting AYE. The President declared the motion carried.

C.C.C. camps to have fireworks display

Lieutenant LeBarron requested that the C.C.C. Camps be allowed permission to have a display of fireworks on the Fourth of July, somewhere where they might be enjoyed by the children of the City. Each of the five camps in this locality were donating \$20.00 to buy the fireworks. The Council commended Lieutenant LeBarron for his attitude and suggested that they be displayed on the Golf Course or Hard ball diamond, and that they children could be seated in the grand stand at Lincoln Park to watch the display.

Councilman Carson reported that several of the intersections on Twelfth Street were dangerous because of shrubs and trees being so thick directly at the intersection.

It was moved by Councilman Oates and seconded by Councilman Carson that the meeting adjourn until Wednesday, June 30th at 7:30 o'clock P.M. Motion carried.
