The City Council of the City of Grand Junction, Colorado, met in regular adjourned session at 7:30 o'clock P. M. Councilmen present and answering at roll call were - President Enstrom, and Councilmen Ross, Holcombe, Groves, Boston, Carson, and Oates. City Manager Soderstrum, City Attorney Bowie and City Clerk Tomlinson were present.

Fidel tax offer

Mr. Anthony Fidel made the highest bid for the tax certificates against Lots 1 and 2, Block 66 at the sale held June 22, 1937. He bid \$149.32 for the certificates.

It was moved by Councilman Carson and seconded by Councilman Oates that the City Treasurer be instructed to sell and assign Special Assessment Tax Sale Certificates Nos. 36854 -37077-8; 37162-3; 37236-7, for the sum of \$149.32, plus the 1937 specials in full, at any time within thirty days from and after this date, providing the purchaser and assignee thereof pay or settle the general taxes on the property in question within such period. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

The following Resolution was then presented and read.

Mgr. authorized to sell Lots 1 & 2, Blk 66

RESOLUTION

IT IS RESOLVED by the City Council of the City of Grand Junction, Colorado, that J. P. Soderstrum, as City Manager of said City, is hereby appointed, authorized and directed, in its name and behalf, to sell Lots 1 and 2, in Block 66, in the City of Grand Junction, County of Mesa and State of Colorado, owned by said City and not used or held by it for any park or governmental purpose, for not less than the sum of \$50.00, and to execute and deliver a quit claim deed and abstract of said property to the purchaser thereof, and to cause the seal of said City to be affixed thereto and attested by the City Clerk.

Passed and adopted this 30th day of June, 1937.

It was moved by Councilman Carson and seconded by Councilman Oates that the resolution be passed and adopted as read. Roll was called on the motion with the following result - Councilman voting AYE - Ross, Holcombe, Groves, Boston, Carson, Oates and Enstrom. All the Councilmen voting AYE, the President declared the motion carried.

Geo. Fleming tax offer rejected

Mr. Geo. W. Fleming offered \$117.64 for the tax sale certificates against the Winnie McKissen tract on South 7th St. It was moved by Councilman Carson and seconded by Councilman Holcombe that the offer be rejected. Motion carried.

Meat ordinance

The Proof of Publication to the Ordinance entitled, "AN ORDINANCE REGULATING THE APPOINTMENT OF A CITY VETERINARIAN AND DEPUTY VETERINARIAN AND PRESCRIBING THE DUTIES THEREOF: REGULATING THE INSPECTION, SLAUGHTERING, SALE AND CARE OF MEAT AND PRESCRIBING PENALTIES FOR VIOLATING THEREOF" was presented and read. It was moved by Councilman Carson and seconded by Councilman Ross that the Proof of Publication be accepted and filed. Motion carried.

It was then moved by Councilman Ross and seconded by Councilman Oates that the Ordinance be passed for publication. Motion carried.

amendments

It was then moved by Councilman Holcombe and seconded by Councilman Carson that the following amendments to the Proposed Ordinance be made -

That Section 4 be amended as follows - In Line 2 the words "Board of Health" be changed to "Health Department".

That Section 6 be amended as follows - In line 6, delete the words "within the City".

That Section 11 be amended as follows - In the Fifth line, following the word "oil", interline the words "or indelible dye".

In Section 12 Line 4 - should read "or any place where any fresh meats or fresh fish, are"

In Section 13 Lines 3 and 4 should read, "grocery store, slaughter house where any fresh meats or fresh fish, are offered or exposed for sale, or sold or"

In Section 26, Line 4 should read, "of Grand Junction, and no hides or offal shall at any time be".

In Section 39, Line 4 and 5 should read, "to be used for human food, within the City of Grand Junction, shall be removed from any slaughter house or slaughtering place before it has".

Roll was called on the motion and all members of the Council voted Aye.

Ord. No. 588

It was then moved by Councilman Ross and seconded by Councilman Boston that the ordinance entitled, "AN ORDINANCE REGULATING THE APPOINTMENT OF A CITY VETERINARIAN AND DEPUTY VETERINARIAN AND PRESCRIBING THE DUTIES THEREOF: REGULATING THE INSPECTION, SLAUGHTERING, SALE AND CARE OF MEAT AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF, BE PASSED and adopted, as amended, numbered 578 and published. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

It was moved by Councilman Oates and seconded by Councilman Ross that the meeting adjourn. Motion carried.
