

Grand Junction, Colorado

November 23, 1938

The City Council of the City of Grand Junction, Colorado, met in regular adjourned session at 7:30 o'clock P.M. Councilmen present and answering at roll call were: Holcombe, Enstrom, Boston, Carson, Oates, and President Groves. Councilman Ross was absent. City Manager Soderstrum, City Attorney Hinman and City Clerk Tomlinson were present.

A Change order request was presented for the distribution of funds on the Sewer and Disposal Project Colo. 1204-F, as follows:

Change Order No. 1 Sewers

(a) "The sum of \$8,384.03, which is on hand and available for the

purpose of construction of sewage disposal plant and intercepting sewers is hereby appropriated for such purpose." "The City Treasurer is hereby ordered to do all things necessary to transfer said sum to the construction account."

(b) "IT IS, THEREFORE, ORDERED that the funds available for the construction of the above project be redistributed and reappropriated to the payment in the amounts and for the purposes hereinabove set forth."

(c) "The proper person is hereby authorized to execute all necessary documents to secure the approval of the changes sought."

It was moved by Councilman Enstrom and seconded by Councilman Carson that the Project Change Order Request No. 1 Colo. 1204-F, be approved by the Council and duly authorized. Roll was called on the motion with all members of the Council present voting AYE. The President declared the motion carried.

A petition was presented, signed by persons living along the County road to Connecticut Lakes, requesting that the City sign this petition to the County Commissioners asking that they improve the road. It was agreed that Mr. Soderstrum should sign the petition.

Mrs. Andrews, owner of the Peach Bowl Cafe, appeared before the Council, and discussed with them the matter of securing a liquor license for her restaurant. No definite statement was made by the Council.

Xmas decorations

The matter of decorating the streets for the Christmas holidays was brought up and discussed. It was moved by Councilman Holcombe and seconded by Councilman Boston that the streets be decorated and lighted on December 10th. Roll was called on the motion with the following result: Councilmen voting AYE - Holcombe, Boston, and Groves. Councilmen voting NO - Enstrom, Carson and Oates. The vote being a tie, the President declared the matter still open for discussion.

Councilman Carson then moved and Councilman Enstrom seconded the motion that the date for the lighting of the streets be set as December 5th. Roll was called on the motion with the following result: Councilmen voting AYE - Enstrom, Carson, Oates. Councilmen voting NO - Holcombe, Boston, and Groves. The vote was again tied.

Councilman Boston then moved that the decorations be put up and the lights lit on December 7th. Roll was called on the motion with the following result: Councilmen voting AYE - Holcombe, Boston, Oates, and Groves. Councilmen voting NO - Enstrom and Carson. A majority of the Councilmen present voting AYE, the President declared the motion carried.

The budget for the year 1939 was brought up and discussed. Mr. Soderstrum had submitted the proposed budget on November 2nd so that each Councilman could study the budget.

It was moved by Councilman Enstrom and seconded by Councilman Holcombe that the mill levy for the year 1939 be set at 15 1/2 mills for City purposes. Roll was called on the motion with the following result: Councilmen voting AYE - Holcombe, Enstrom, Boston, Carson, Oates and Groves. Councilmen voting NO - None. All of the Councilmen present voting AYE, the President declared the motion carried.

1939 levy

It was moved by Councilman Carson and seconded by Councilman Holcombe that the meeting adjourn until Friday evening November 25th, at 7:30 o'clock P.M. Motion carried.
