The City Council of the City of Grand Junction, Colorado, met in regular session at 7:30 o'clock P.M. Councilmen present and answering at roll call were: Ross, Holcombe, Campbell, Luebbert, Carson, Treece, and President Boston. City Attorney Hinman, Acting City Manager Brownson and City Clerk Tomlinson were present.

The minutes of the regular meeting held August 16th, the regular adjourned meeting held August 30th and the special meeting held August 30th and the special meeting held September 1st were read and approved.

The petitions for bringing Slocomb's Addition into the City and the remonstrance petitions having been checked by Mr. McGillis, it was discovered that more than 50% of those qualified had not signed the petition asking that this property be brought into the City. The Council therefore could not act at this time. It was therefore moved by Councilman Carson and seconded by Councilman Ross that the petitions be tabled indefinitely. Motion carried.

THEREFORE, BE IT RESOLVED, That the improvements connected therewith in said district be and the same are hereby accepted; that the said statement be and the same is hereby approved and accepted as the statement of the whole cost of the entire improvements of said Paving District No. 44, including two percent additional for cost of collection and other incidentals and including interest to and including the 29th day of February, 1940; and

BE IT FURTHER RESOLVED, That the same be apportioned on each lot or tract of land or other real estate, to be assessed for the same, and that the same be certified by the President of the Council and filed in the office of the City Clerk; and

It was moved by Councilman Holcombe and seconded by Councilman Carson that the Resolution be passed and adopted as read. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

The application of Wm. H. Orchard and E. S. McConkie, for a restaurant liquor license for the Golden Pheasant Cafe, was presented. It was moved by Councilman Carson and seconded by Councilman Campbell that the license be granted. Motion carried.

Mr. N. Grasso presented a bond for cement contractor, having been approved as to form by City Attorney Hinman. It was moved by Councilman Holcombe and seconded by Councilman Ross that the bond be accepted and filed. Motion carried.

An Ordinance entitled, "AN ORDINANCE CONCERNING SALARIES, was presented. It was moved by Councilman Campbell and seconded by Councilman Holcombe, that the ordinance be passed and adopted as an emergency ordinance, numbered 614 and published. Roll was called on the motion with the following result: Councilmen voting AYE - Ross, Holcombe, Campbell, Luebbert, Carson, Treece and Boston. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.

F. I. Stringer, City Treasurer asked for authorization to pay the balance of Paving District #18 bonds, in the amount of approximately \$11,000. It was moved by Councilman Ross and seconded by Councilman Luebbert that authorization be given to the City Treasurer to pay the balance of Paving District No. 18 bonds in the amount of approximately \$11,000 from funds in the U.S. Bank Trust fund. Roll was called on the motion with the following result: Councilmen voting AYE - Ross, Holcombe, Campbell, Luebbert, Carson, Treece, and Boston. Councilmen voting NO - None. All of the Councilmen voting AYE, the President declared the motion carried.

It was reported to the Council that there will be approximately \$24,000.00 left in the Water Filtration Plant

Account after all bills are paid for the construction of the filter plant. It was suggested that this money be used to purchase additional 20-inch pipe to be used in the flowline. It was moved by Councilman Holcombe and seconded by Councilman Carson that the balance of the money derived from the sale of the Water Revenue Refunding Bonds, after all bills have been paid for the construction of the filter plant, be used for the purchase of 20-inch cast iron pipe and installation of same in the flowline. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

Mr. Soderstrum, former City Manager has agreed to complete his studies of means of providing revenue for the maintenance of the sewer system and to submit a proposed ordinance, together with other pertinent date for the sum of \$200.00. It was moved by Councilman Campbell and seconded by Councilman Treece that Mr. Soderstrum be employed to draw up an ordinance to provide for maintaining the sewer system in the City for the sum of \$200.00. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

Mr. Weiser made the request that the City of Grand Junction authorize the State Highway Dept. to transfer the balance in the 3% gas tax fund for use on the Uravan road, as the County do not have sufficient funds to enable them to carry out the W.P.A. project established for the improvement of this road.

It was moved by Councilman Carson and seconded by Councilman Campbell that the City authorize Chas. Vail, State Highway Engineer, to transfer the unexpended balance of the 3% state gas tax money allocated to Grand Junction to the Uravan road (State Highway No. 141) in order that the WPA project for said highway might continue to function. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

The following resolution was introduced and read, and it was moved by Councilman Carson and seconded by Councilman Ross that it be passed and adopted:

RESOLUTION

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION that we commend J. P. Soderstrum for his long, faithful and efficient administration of the office of City Manager of this City and for the many splendid achievements obtained by our City during his term of office.

Mr. Soderstrum leaves office with our best wishes and respect and we heartily endorse and recommend him for like appointment by any other municipality or to any other position to which he may aspire by reason of his training and ability. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

A letter from the Pacific Coast Building Officials Conference in which they requested that Mr. J.D. McGillis, Building Inspector be allowed to attend the conference in Oakland, California. Mr. McGillis was requested to obtain the approximate cost of this trip and report same to Council at the next regular meeting.

It was moved by Councilman Carson and seconded by Councilman Holcombe that the meeting adjourn. Motion carried.
