Grand Junction, Colorado

August 28, 1940

The City Council of the City of Grand Junction, Colorado, met in regular adjourned session at 7:30 o'clock P.M. Councilmen present and answering at roll call were: Garrison, Campbell, Boston, Carson, Treece and President Ross. Councilman Luebbert was absent. City Manager Brownson, City Attorney Hinman and City Clerk Tomlinson were present.

Mr. G. W. Robinson appeared before the Council and stated that Dr. Townsend would be in Grand Junction on September 5th and that they were planning on a meeting at Lincoln Park in the evening. He requested that the President of the Council give the address of welcome, and that they be granted the use of the Athletic Field on the same terms as they had last year. It was moved by Councilman Carson and seconded by Councilman Boston that the request of the Townsend Club be granted and they be allowed the use of the Athletic Field on the same basis as last year. Motion carried.

The Lion's Club requested that part of the charges for the use of the Athletic Field for the Pasadena Junior College Concert be rebated. City Manager Brownson reported that the expenses for the use of the field were - \$12.00 for lights and approximately \$28.00 for setting up bleachers, etc. It was moved by Councilman Carson and seconded by Councilman Campbell that the Lion's Club be charged the actual expenses for the field. Roll was called on the motion and all members of the Council present voted AYE. The President declared the motion carried.

At the time of the Regional Band Tournament a bill was rendered for the use of the Athletic Field for the Mass Band Concert - \$12.00 for the lights, 10% of the gate, and the cost of the setting up bleachers, etc. In remitting this amount, only the \$12.00 was paid, the other being over-looked. All funds have been transferred now, and there are no more funds available from the Band Tournament Committee. It was moved by Councilman Campbell and seconded by Councilman Carson that the actual expenses for the field be charged, and that it be collected at the earliest opportunity. Motion carried.

An application was made for a one and one-half inch water main at 707 North First Street by Mary and George Hicks. It was moved by Councilman Carson and seconded by Councilman Treece that the application be granted. Motion carried.

The Home Builders Supply Co. applied for a permit to build a spur track across Rice Street. It was agreed that the Council would grant this permission, but that the request should be made by the Railroad Co.

Several matters pertaining to amendments for ordinances were

brought up and discussed.

A letter was read from Mr. McGillis, Building Inspector, in regard to building permit fees. Considerable discussion was had on this matter and it was then moved by Councilman Carson and seconded by Councilman Campbell that the Council approve the recommendations of the Building Inspector and authorize the City Manager and City Attorney to draw up an ordinance in compliance therewith. Motion carried.

It was then moved by Councilman Carson and seconded by Councilman Garrison that Ordinance No. 504 relating to the selling fruits, vegetables, etc. at wholesale brought into the City by truck, be repealed. Roll was called on the motion with the following result: Councilmen voting AYE - Garrison, Carson. Councilmen voting NO - Campbell, Boston, Treece and Ross. A majority of the Council voting NO, the motion was declared lost.

The matter of charging license fees for operating card tables was brought up and discussed but the entire Council was opposed to such a license fee.

It was moved by Councilman Garrison and seconded by Councilman Carson that the meeting adjourn. Motion carried.
