Grand Junction, Colorado

January 22, 1941

The City Council of the City of Grand Junction, Colorado, met in regular adjourned session at 7:30 o'clock P.M. Councilmen present and answering at roll call were: Robb, Garrison, Campbell, Boston, Carson, Treece, and President Ross. City Manager Brownson, City Attorney Hinman, and City Clerk Tomlinson were present.

Mr. Thomas Yuille appeared before Council in connection with the request for a liquor store license, which had been filed with the Council on January 8th. He requested that the Council take some action on the matter of issuing a license to J. E. White and Thomas Yuille, as they could not hold the building they had in mind, if the license was not to be issued. Mr. Wm. Pantuso, also appeared before the Council and was anxious that the Council act on his liquor store application.

It was moved by Councilman Campbell and seconded by Councilman Treece that the Council rescind the action to postpone consideration of the liquor license applications of Yuille and White and Wm. Pantuso until the next regular meeting of the Council, and call the matter up for action at this meeting of the Council. Roll was called on the motion with the following result: Those voting AYE - Robb, Garrison, Campbell, Boston, Treece. Those voting NO - Carson and Ross. A majority of the Council voting AYE, the President declared the motion carried.

Mr. Brownson was called upon to read a letter which he had written to the Council on August 21st, 1940, in connection with the consideration of so many liquor applications.

It was moved by Councilman Garrison and seconded by Councilman Robb that liquor store licenses be granted to J. E. White and Thomas Yuille at 409 Main Street and Wm. Pantuso at 338 Main St. Roll was called on the motion with the following result; Those voting AYE - Robb and Garrison. Those voting NO - Campbell, Boston, Carson, Treece and Ross. A majority of the Councilmen voting No, the motion was declared lost, and the licenses not granted.

No protests were filed in connection with the assessments against Paving District No. 46.

A proposed ordinance entitled, "An Ordinance Approving the Whole Cost of the Improvements Made in and for Paving District No. 46, in the City of Grand Junction, Colorado, Pursuant to Ordinance No. 178, Adopted, and Approved the 11th day of June, 1910, as Amended; Approving the Apportionment of Said Cost to Each Lot or Tract of Land or Other Real Estate in said District; Assessing the Share of Said Cost Against each Lot or Tract of Land or Other Real Estate in Said District; and Approving the Apportionment of Said Cost; and Prescribing the Manner for the Collection and Payment of said Assessments", was introduced and read. It was moved by Councilman Campbell and seconded by Councilman Garrison that the ordinance be passed for publication. Motion carried.

The Proof of Publication to the Proposed Ordinance entitled, "AN ORDINANCE APPROVING THE WHOLE COST OF THE IMPROVEMENTS MADE IN AND FOR COMBINED SEWER DISTRICT NO. 8, IN THE CITY OF GRAND JUNCTION, COLORADO, PURSUANT TO ORDINANCE NO. 178, ADOPTED AND APPROVED THE 11th DAY OF JUNE, 1910, AS AMENDED: APPROVING THE APPORTIONMENT OF SAID COST TO EACH LOT OR TRACT OF LAND OR OTHER REAL ESTATE IN SAID DISTRICT: ASSESSING THE SHARE OF SAID COST AGAINST EACH LOT OR TRACT OF LAND OR OTHER REAL ESTATE IN SAID DISTRICT: AND APPROVING THE APPORTIONMENT OF SAID COST: AND PRESCRIBING THE MANNER FOR THE COLLECTION AND PAYMENT OF SAID ASSESSMENTS, was presented and read. It was moved by Councilman Carson and seconded by Councilman Treece that the Proof of Publication be accepted and filed. Motion carried.

It was then moved by Councilman Campbell and seconded by Councilman Carson that the ordinance be called up for final passage. Motion carried.

Councilman Boston then moved and Councilman Garrison seconded the motion that the Ordinance be passed and adopted, numbered 640 and published. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

The Proof of Publication to the Proposed Ordinance entitled, "AN ORDINANCE REPEALING ORDINANCE NO. 504", was introduced and read. It was moved by Councilman Boston and seconded by Councilman Treece that the Proof of Publication be accepted and filed. Motion carried.

It was then moved by Councilman Robb and seconded by Councilman Garrison that the Ordinance be called up for final passage. Motion carried.

The Ordinance was then read and Councilman Campbell moved and Councilman Robb seconded the motion that it be passed and adopted numbered 641 and published. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

The Proof of Publication to the Proposed Ordinance entitled, "AN ORDINANCE RELATING TO TOPE SCHOOL SUBDIVISION AND THE WEST ONE-HALF OF BLOCK "A", COLLEGE SUBDIVISION TO THE CITY OF GRAND JUNCTION", was introduced and read. It was moved by Councilman Carson and seconded by Councilman Treece that the Proof of Publication be accepted and filed. Motion carried.

It was then moved by Councilman Boston and seconded by Councilman Treece that the ordinance be called up for final passage. Motion carried.

The Ordinance was then read and upon motion of Councilman Robb and seconded by Councilman Campbell was passed and adopted, numbered 642 and published. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

A map showing proposed changes in the Voting Districts was submitted. The following Resolution was presented and read:

RESOLUTION

CHANGING THE BOUNDARIES OF THE VOTING DISTRICTS CREATED BY SECTION 36, ARTICLE IV OF THE CITY CHARTER.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION:

That the boundaries of the Voting Districts created by the Charter of the City of Grand Junction and particularly Section 56 of Article IV thereof, be and the same are hereby changed, so that, as now changed, said Districts shall be hereafter described and designated as follows:

<u>District "A"</u> shall contain and include all that portion of the City of Grand Junction lying west of Seventh Street and south of Main Street.

<u>District "B"</u> shall contain and include all that portion of the City of Grand Junction lying north of Main Street and west of Fifth Street and west of the center line of Fifth Street extended northward from North Avenue to the City limit line.

<u>District "C"</u> shall contain and include all that portion of the City of Grand Junction lying north of Main Street and north of North Avenue and east of Fifth Street and east of Fifth Street extended northward from North Avenue to the City limits, and west of Eighth Street between Main Street and North Avenue.

<u>District "D"</u> shall contain and include all that portion of the City of Grand Junction lying east of Seventh Street from the south City limits, north to Main Street, and east of that portion of Eighth Street between Main Street and Grand Avenue, and south of that portion of Main Street lying between Seventh and Eighth Streets, and south of that portion of Grand Avenue from Eighth Street, eastward to the City limit line.

<u>District "E"</u> shall contain and include all that portion of the City of Grand Junction lying between Grand Avenue and North Avenue and east of Eighth Street.

All Districts bounded on streets and avenues shall extend to

and be divided by the center lines thereof.

It was moved by Councilman Campbell and seconded by Councilman Garrison that the Resolution be passed and adopted as read. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

Mrs. F. A. Brumbaugh has requested the free use of Lincoln Park Auditorium on January 30 for the annual President's Ball. She states that the orchestra is donating their time and other services are likewise being donated. It was moved by Councilman Carson and seconded by Councilman Boston that the request be granted. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

A letter was read from Mr. Wolfe of the Western Air Express Corp., Burbank, California, suggesting that the City Council pass a resolution endorsing air service through Grand Junction. The following resolution was presented and read:

RESOLUTION

BE IT RESOLVED: That the City Council of the City of Grand Junction, Colorado, is of the opinion without dissent that air transportation to Denver, Colorado, and points east, and to Los Angeles, California, is necessary to respond to the transportation requirements of the citizens of Grand Junction and the inhabitants of the surrounding territory; and in furtherance of that opinion this Council urges the inauguration and maintenance of such air transportation service, and endorses the application now pending before the Civil Aeronautics Board under which Western Air Express Corporation is seeking authority to maintain air transportation service between Denver, Colorado, and Los Angeles, California, via Grand Junction, Colorado, and Las Vegas, Nevada.

It was moved by Councilman Carson and seconded by Councilman Treece that the Resolution be passed and adopted as read. Roll was called on the motion with all members of the Council voting AYE. The President declared the motion carried.

A letter from Grand Junction Local No. 131 of the American Security Union was read. The letter requested that the Council go on record as favoring some kind of a National Defense Program in Grand Junction, and that they use all possible means to secure some project for this City. It was moved by Councilman Carson and seconded by Councilman Campbell that the City Council accept the letter and that the American Security Union be advised that the Council is co-operating along this line. Motion carried.

The matter of two-hour parking on Rood Avenue was brought up and discussed. It was moved by Councilman Campbell and seconded by Councilman Carson that the City Attorney be instructed to draw up an ordinance requiring that Rood Avenue from Third Street to Seventh Street and North Avenue from Tenth To Twelfth Street observe two-hour parking rules. Motion carried.

Bonds which had been approved by City Attorney Hinman were presented, as follows: George O. Wilson and J. W. Rader, Plumbers; Charles W. Black, Cement Contractor; Lee O. Treece, pawn broker; Wesley P. Cornell, Electrician; and Floyd S. Carpenter, Auctioneer. It was moved by Councilman Campbell and seconded by Councilman Treece that the bonds be accepted and filed. Motion carried.

Mr. Brownson, City Manager, stated that he had been quoted a very good price on six-inch pipe for water mains, and also that he had written to C.F. & I. asking if they would still sell 20-inch C.I. pipe for the same price as they quoted a short time ago. Mr. Brownson stated that he felt it would be wise to continue the flow-line project at this time, if at all possible.

It was moved by Councilman Carson and seconded by Councilman Garrison that Mr. Brownson be authorized to order a carload of six-inch pipe and to secure more 20-inch C.I. pipe on a continuing order, if possible. Motion carried.

It was moved by Councilman Carson and seconded by Councilman Boston that the meeting adjourn. Motion carried.
